- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable A. G. Cameron) took the Chair, and read Prayers.
- 2. MINISTERIAL ARRANGEMENTS.-Mr. Menzies (Prime Minister) announced that, during the absence through illness of Mr. McEwen (Minister for Commerce and Agriculture) and Senator O'Sullivan (Minister for Trade and Customs), Senator McLeay (Minister for Shipping and Transport) would act both as Minister for Commerce and Agriculture and Minister for Trade and Customs. Mr. Anthony (Postmaster-General) would represent the Acting Minister for Commerce and Agriculture in this House, and, in the Senate, Senator McLeay would act as Leader of the Senate and would represent the Prime Minister and the Minister for Defence.

- 7. Defence Forces Retirement Benefits Bill 1953 .- Sir Philip McBride (Minister for Defence) moved, by leave, That he have leave to bring in a Bill for an Act to amend the Defence Forces Retirement Benefits Act 1948-1952.

Question—put and passed. Sir Philip McBride then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Sir Philip McBride moved, by leave, That the Bill be now read a second time.

Mr. Chambers moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

8. Message from the Governor-General.—New Guinea Timber Agreement Bill 1953.—Mr. Speaker announced the receipt of the following Message from His Excellency the Governor-General:-

W. J. SLIM,

Governor-General.

Message No. 1.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the New Guinea Timber Agreement Act 1952.

Canberra, 18th November, 1953.

Ordered-That the foregoing Message be taken into consideration, in Committee of the whole House,

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Mr. Hasluck (Minister for Territories) moved, That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the New Guinea Timber Agreement Act 1952. Question—put and passed. Resolution to be reported.

The House resumed; Mr. Adermann reported accordingly.

Mr. Hasluck moved, pursuant to contingent notice, That so much of the Standing Orders be suspended as would prevent the remaining stages being passed without delay.

Question—put and passed.

On the motion of Mr. Hasluck, the Resolution reported from the Committee was adopted by the House. Ordered-That Mr. Hasluck and Sir Philip McBride do prepare and bring in a Bill to carry out the foregoing Resolution.

Mr. Hasluck then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Hasluck moved, That the Bill be now read a second time. Mr. Calwell moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

9. Sales Tax Assessment Bill (No. 5) 1953.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time Debate resumed.

On the motion of Sir Earle Page (Minister for Health), the House adopted the Report, and, by leave, the Bill was read a third time.

11. GWYDIR ELECTORAL DIVISION—ISSUE OF WRIT.—Mr. Speaker informed the House that it was his intention to issue a Writ, on Tuesday, the 24th instant, for the Election of a Member to serve for the Electoral Division of Gwydir, in the State of New South Wales, in the place of Mr. Thomas John Treloar, deceased. 12. NATIONAL HEALTH BILL 1953 [No.2].—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-

Debate resumed by Mr. A. D. Fraser, who moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof:—"the Bill be withdrawn and redrafted to place greater emphasis through co-operation with the States and Local Authorities on the promotion of positive health-

(a) in the establishment and maintenance of diagnostic and health centres;

(b) in dental care of children under sixteen years of age;

. .

(c) in the provision of medical training and research facilities and a system of regional hospitals; and to provide-

(1) for substantially increased rates of hospital benefit having regard to the rise of hospital costs:

(2) for the negotiation of fresh agreements between the Commonwealth and the States to ensure that throughout Australia there should be no charge and no means test for qualified

patients occupying beds in public wards of public hospitals;
(3) that payment of Commonwealth Hospital Benefits or Medical Benefits shall not be conditional upon a patient being a contributor to a Hospitals Fund or a Medical Benefits

Fund:

(4) that registered organizations shall be subsidized to ensure that their benefits will be extended to chronic sufferers and those suffering disabilities at the commencement of their membership of registered organizations;

(5) to devise in consultation with the medical profession and State Governments machinery to stabilize medical charges and to determine just variations of those charges;

(6) that Medical Benefits be extended to mileage charges of medical practitioners incurred by patients especially those in outback areas;

(7) that the provision of medical and hospital benefits should be financed from revenue raised on a graduated scale based upon capacity to pay;
(8) for the cure and relief of mental illness ".

Ordered—That Mr. A. D. Fraser be granted an extension of time.

Debate continued.

Mr. Pearce moved, That the dehate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for the next sitting.

13. Adjournment.—Mr. Eric J. Harrison (Vice-President of the Executive Council) moved, That the House do now adjourn.

Question—put and passed.

And then the House, at twenty-two minutes to twelve o'clock midnight, adjourned until to-morrow at ten o'clock a.m.
