Sir Eric Harrison (Vice-President of the Executive Council) moved, That, towards making good the Supply granted to Her Majesty for the service of the year 1954-55, there be granted out of the Consolidated Revenue Fund the sum of £289,138,000. Question—put and passed.

Resolution to be reported, and leave asked to sit again.

The House resumed; Mr. Adermann reported accordingly. Resolved—That the House will, at the next sitting, again resolve itself into the said Committee.

On the motion of Sir Eric Harrison, the Resolution reported from the Committee was adopted by the House.

Ordered-That Sir Eric Harrison and Mr. Kent Hughes do prepare and bring in a Bill to carry out the foregoing Resolution.

6. Appropriation Bill 1954-55.—Sir Eric Harrison (Vice-President of the Executive Council) then brought up a Bill intituled "A Bill for an Act to grant and apply out of the Consolidated Revenue Fund a sum for the service of the year ending the thirtieth day of June, One thousand nine hundred and fiftyfive, and to appropriate the Supplies granted by the Parliament for that year", and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Sir Eric Harrison moved, That the Bill be now read a second time.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Bill, by leave, taken as a whole, and agreed to.
