- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable A. G. Cameron) took the Chair, and read Prayers.
- 2. RETURN TO WRIT-COOK DIVISION.-Mr. Speaker announced that he had received a Return to the Writ which he had issued on the 21st April for the election of a Member to serve for the Electoral Division of Cook, in the State of New South Wales, to fill the vacancy caused by the death of Mr. Thomas Sheehan, and that by the endorsement on the Writ, it was certified that James Francis Cope had been elected.
- 3. Member Sworn.—James Francis Cope, Esquire, was introduced, and made and subscribed the Oath required by law.
- 4. MINISTERIAL ARRANGEMENTS.-Mr. Menzies (Prime Minister) informed the House that, during the absence abroad of Senator Spicer, he would act as Attorney-General, and in the Senate, Senator O'Sullivan (Minister for Trade and Customs) would represent the Acting Attorney-General, the Minister for External Affairs and the Minister for Territories, Senator Spooner (Minister for National Development) would represent the Minister for Labour and National Service and the Minister in charge of the Commonwealth Scientific and Industrial Research Organization, and Senator McLeay (Minister for Shipping and Transport) would represent the Minister for Immigration.

8. Electoral Divisions of New South Wales—Proposed Redistribution.—Mr. Kent Hughes (Minister for the Interior) moved, by leave, That the House of Representatives approves of the distribution of the State of New South Wales into Electoral Divisions, as proposed by Messrs. V. F. Turner, H. J. Martin and G. W. Vincent, the Commissioners appointed for the purpose of distributing the said State into Divisions, in their Report laid before the House of Representatives on the 3rd day of May, 1955, and that the names of the Divisions suggested in the Report, and indicated on the maps referred to therein, be adopted, except that the name "Grayndler" be substituted for "Cook", the name "Hughes" for "Werriwa" and the name "Werriwa" for "Hughes".

Debate adjourned (Mr. Johnson), and the resumption of the debate made an Order of the Day for the next sitting.

12. ELECTORAL DIVISIONS OF TASMANIA—PROPOSED REDISTRIBUTION.—Mr. Kent Hughes (Minister for the Interior) moved, by leave, That the House of Representatives approves of the distribution of the State of Tasmania into Electoral Divisions, as proposed by Messrs. E. W. Dwyer, F. Miles and E. C. Botten, the Commissioners appointed for the purpose of distributing the said State into Divisions, in their Report laid before the House of Representatives on the 3rd day of May, 1955, and that the names of the Divisions suggested in the Report, and indicated on the map referred to therein, be adopted, except that the name "Braddon" be substituted for "Darwin".

Debate adjourned (Mr. Duthie), and the resumption of the debate made an Order of the Day for the next sitting.

- 13. Suspension of Standing Orders.—Sir Eric Harrison (Vice-President of the Executive Council) moved, by leave, That so much of the Standing Orders be suspended as would prevent Order of the Day No. 1, General Business, being proceeded with forthwith. Question—put and passed.
- 14. COMMITTEE OF PRIVILEGES-SPECIAL REPORT.—The Order of the Day having been read for the resumption of the debate on the following motion of Mr. Keon, That the Committee's request be acceded to-

Question—put and passed.

15. COURTS-MARTIAL APPEALS BILL 1955—SENATE'S AMENDMENTS.—The Order of the Day having been read for the consideration in Committee of the whole House of the Amendments made by the Senate

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

The Committee proceeded to consider the Amendments, which are as follows:-

SCHEDULE OF THE AMENDMENTS MADE BY THE SENATE.

No. 1.—Page 7, clause 20, lines 39 to 47, leave out sub-clause (2.), insert the following sub-clause :-"(2.) A person is not entitled to apply for leave to appeal to the Tribunal against a conviction, other than a conviction involving sentence of death-

(a) unless he has, within the prescribed period, lodged a petition praying that the conviction be quashed by the prescribed authority; and

(b) subject to sub-section (2.) of the next succeeding section, unless-

(i) he has been notified that the petition has been refused; or

(ii) the prescribed period after the day on which the petition was lodged has expired."

No. 2.—Page 11, clause 30, line 20, leave out "Subject to Part V.,".
No. 3.—Page 11, clause 30, line 22, leave out "is final and conclusive", insert "is not subject to review under naval law, military law or air force law".

On the motion of Sir Philip McBride (Minister for Defence), the Amendments were agreed to, after debate.

Resolution to be reported.

The House resumed; Mr. Adermann reported accordingly. On the motion of Sir Philip McBride, the House adopted the Report.

16. DEFENCE FORCES RETIREMENT BENEFITS BILL 1955 .- The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-

Debate resumed. Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clause 1-

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Adermann reported accordingly.

Resolved—That the House will, at a later hour this day, again resolve itself into the said Committee.

17. Message from the Governor-General-Defence Forces Retirement Benefits Bill 1955. Mr. Speaker announced the receipt of the following Message from His Excellency the Governor-General:--

Message No. 48.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the Defence Forces Retirement Benefits Act 1948-1954.

The House resumed; Mr. Adermann reported accordingly.

On the motion of Sir Philip McBride (Minister for Defence), the House adopted the Report, and, by leave, the Bill was read a third time.

 SALARIES ADJUSTMENT BILL 1955.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time— Debate resumed.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to, after debate.

Bill to be reported without amendment.

The House resumed; Mr. Bowden reported accordingly.

On the motion of Mr. Menzies (Prime Minister), the House adopted the Report, and the Bill was read a third time.

20. Judges' Remuneration Bill 1955.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—

Debate adjourned (Mr. Whitlam), and the resumption of the debate made an Order of the Day for the next sitting.
