6. PUBLIC WORKS COMMITTEE—REFERENCE OF WORK—COMMUNITY HOSPITAL, CANBERRA.—Mr. Fairhall (Minister for Works) moved, pursuant to notice, That, in accordance with the provisions of the *Public Works Committee Act 1913–1953*, the following proposed work be referred to the Parliamentary Standing Committee on Public Works for investigation and report on the need, suitability of the site, and proposed method of implementation, namely :—Erection of a Community Hospital at Canberra.

Mr. Fairhall laid on the Table plans in connexion with the proposed work.

Question—put and passed.

7. WAYS AND MEANS—MEAT EXPORT (ADDITIONAL CHARGE).—The Order of the Day having been read for going into the Committee of Ways and Means—
Question—That Mr. Deputy Speaker do now leave the Chair—put and passed.
Whereupon Mr. Deputy Speaker left the Chair, and the House resolved itself into the Committee of Ways and Means—

(In the Committee.)

Mr. McMahon (Minister for Primary Industry) moved—

1. That the charge imposed in pursuance of this Resolution be in lieu of the charge imposed by the *Meat Export (Additional Charge) Act 1955*.
2. That the Act passed to give effect to the Resolution be deemed to have come into operation on the first day of February, One thousand nine hundred and fifty-six.
3. That, in this Resolution, unless the contrary intention appears—
 - “edible offal” mean any edible portion, other than the flesh, of cattle or sheep;
 - “excess payment”, in relation to a year, mean the amount by which deficiency payments by the Board under section five of the *Meat Agreement (Deficiency Payments) Act 1955* in respect of that year, together with expenses (including interest charges) incurred by the Board in connexion with those payments, exceed payments by the Government of the United Kingdom to the Government of the Commonwealth under the Meat Agreement referred to in that Act, in respect of that year;
 - “meat” mean beef, veal, mutton, lamb and edible offal, but do not include canned meat;
 - “the Board” mean the Australian Meat Board constituted under the *Meat Export Control Act 1935–1953*;
 - “the Minister” mean the Minister of State for the time being administering the Act passed to give effect to this Resolution;
 - “year” mean a period of twelve months ending on the thirtieth day of September.
- 4.—(1.) That for the purpose of making good the amount of any excess payment or excess payments made by the Board in respect of a year or years, a charge be imposed and be levied and paid on meat exported from the Commonwealth to the United Kingdom, being meat that was delivered into cold store or cool store on or after the date of commencement of the Act passed to give effect to this Resolution and to which a rate of the charge is applicable under the succeeding provisions of this Resolution.
- (2.) That the Minister be empowered, from time to time, by notice published in the *Gazette*, to fix a rate or rates of the charge in respect of such kinds or classes of meat as are specified in the notice.
- (3.) That a rate fixed by a notice referred to in the last preceding sub-paragraph—
 - (a) come into force on a date specified in the notice; and
 - (b) remain in force up to and including the day next preceding such date as is fixed by the Minister by a later notice published in the *Gazette* as the date on which that rate shall cease to be in force.
- (4.) That the rate of the charge applicable to any meat be the rate (if any) fixed by the Minister that was, on the day on which the meat was delivered into cold store or cool store, in force in relation to meat of a kind or class in which the meat is included.
- (5.) That the Minister be required, as far as he considers it practicable to do so, to exercise his powers referred to in this paragraph in such a way that the amount of the excess payment in respect of a year will be made good by the end of the succeeding year.
5. That the Board be required, from time to time, to make recommendations to the Minister as to the kinds or classes of meat to which the charge should apply and as to the rates of the charge, and the periods of operation of those rates, that are necessary, in the opinion of the Board, to ensure that the amount of the excess payment in respect of a year will be made good by the end of the succeeding year, and the Minister be required, in exercising his powers referred to in the last preceding paragraph, to take those recommendations into consideration.
6. That the charge imposed in pursuance of this Resolution in respect of any meat be payable in addition to the charge (if any) payable in respect of that meat under the *Meat Export Charge Act 1935–1954*,

7.—(1.) That an amount of charge payable in accordance with this Resolution be a debt due to the Commonwealth from the exporter, and that amounts so payable be required to be paid to such officers in the respective States or in the Northern Territory of Australia as the Minister specifies.

(2.) That the charge in respect of any meat be made payable, if an officer specified by the Minister so requires, before the entry of the meat for export.

8. That, notwithstanding the provisions of sub-paragraph (4.) of paragraph four of this Resolution, the rate of one-eighth of one penny per pound be the rate of the charge applicable to meat being first or second quality ox, heifer or cow beef delivered into cold store or cool store on or after the first day of February, One thousand nine hundred and fifty-six, and before such date as is fixed by the Minister, by notice published in the *Gazette*, as the date on which the rate fixed in pursuance of this paragraph shall cease to be in force.

Question—put and passed.

Resolution to be reported, and leave asked to sit again.

The House resumed ; Mr. Bowden reported accordingly.

Resolved—That the House will, at a later hour this day, again resolve itself into the said Committee.
