The House resumed; Mr. Lawrence reported accordingly. Resolved—That the House will, at the next sitting, again resolve itself into the said Committee.

14. ADJOURNMENT.—Mr. H. E. Holt (Minister for Labour and National Service) moved, That the House do now adjourn. Question—put and passed.
