In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the Cotton Bounty Act 1951–1955. Canberra, 20th March, 1957.

Ordered—That the Message be taken into consideration, in Committee of the whole House, forthwith. Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Mr. McMahon (Minister for Primary Industry) moved, That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the Cotton Bounty Act 1951-1955. Question—put and passed.

13. Lands Acquisition Bill 1957.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Adermann reported accordingly.

On the motion of Mr. Fairhall (Minister for the Interior), the House adopted the Report, and, by leave, the Bill was read a third time.
