- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.--Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.
- 2. PETITIONS.—Mr. Beazley presented a Petition from certain citizens of Fremantle and electors of the Federal Division of Fremantle praying that the House take such steps as are possible to solve the unemployment problem of Western Australia.
 - Mr. Lawson presented a Petition from certain members of the Pensioners' League of Queensland praying that the Parliament will give immediate consideration to the question of increasing pensions to no less than 50 per cent. of the basic wage as the minimum.
 - Mr. Harrison presented a Petition from certain electors of the Division of Blaxland and others praying that the Parliament will give early consideration to the question of giving effect to the findings of the World Health Organization as embodied in its Third Report on Environmental Sanitation. Petitions severally received and read.
- 3. MINISTERIAL ARRANGEMENTS.—Sir Arthur Fadden (Treasurer) informed the House that during the absence abroad of Sir Philip McBride, Mr. Beale (Minister for Supply) would act as Minister for Defence.
 - 4. ACTING LEADER OF THE OPPOSITION.—Mr. Calwell informed the House that in the absence overseas of Mr. Evatt, he would act as Leader of the Opposition.

DISCUSSION OF MATTER OF URGENCY—PENSIONS AND BENEFITS.—Mr. Cope having proposed to Mr. Speaker that a definite matter of urgent public importance be submitted to the House for discussion, namely, "The urgent necessity for the Government to grant immediate substantial increases in rates of pensions and benefits to alleviate widespread distress amongst aged, invalid, widowed and repatriation pensioners and recipients of other social services including the unemployed and the sick "—

Mr. Speaker called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly— Mr. Cope addressed the House.
