 consideration be given to the matter of increasing the rate of age, invalid and widows' pensions to at
 least 50 per cent. of the basic wage.

- 4. Discussion of Matter of Urgency—Unemployment.—Mr. Barnard having proposed to Mr. Speaker that a definite matter of urgent public importance be submitted to the House for discussion, namely, "The serious position caused by unemployment in or throughout Australia"—
 - Mr. Speaker called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly—

Mr. Barnard addressed the House.

Discussion ensued.

Ordered—That Mr. H. E. Holt (Minister for Labour and National Service) be granted an extension of time.

Discussion continued.

Ordered-That Mr. Clarey be granted an extension of time.

Mr. Holt moved, that the Business of the Day be called on.

Question-put and passed.

 NATIONAL CAPITAL DEVELOPMENT COMMISSION BILL 1957.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time— Debate resumed.

Question-put and passed.—Bill read a second time.

- 8. AGREEMENT ON COMMERCE BETWEEN AUSTRALIA AND JAPAN—MOTION FOR PRINTING PAPER.—The Order of the Day having been read for the resumption of the debate on the following motion of Mr. McEwen (Minister for Trade), That the Paper (presented on the 27th August, 1957), viz.:—

 Agreement on Commerce between the Commonwealth of Australia and Japan, signed on the 6th

July, 1957—

be printed—
Debate resumed by Mr. Evatt (Leader of the Opposition), who moved, as an amendment, That the following words be added to the motion:—" and this House expresses its disapproval of the Agreement on Commerce between the Commonwealth of Australia and Japan".

Debate continued.

- Debate adjourned (Mr. Bird), and the resumption of the debate made an Order of the Day for the next sitting.
- ADJOURNMENT.—Mr. McEwen (Minister for Trade) moved, That the House do now adjourn.
 Debate ensued.
 Question—put and passed.
