In the meanwhile, he would be represented in the House by Mr. Townley (Minister for Immigration).

St. MARY'S AMMUNITION FILLING FACTORY-MINISTERIAL STATEMENT.-Mr. Menzies (Prime Minister), by leave, made a Ministerial Statement informing the House of the reasons for the Government's decision to construct a new ammunition filling factory at St. Mary's, New South Wales. Mr. Evatt (Leader of the Opposition), by leave, also made a Statement regarding the matter.
