Petition.—Mr. Kearney presented a Petition from certain citizens of Australia praying that the House will give immediate consideration to the matter of increasing the rate of pension to at least 50 per cent. of the basic wage and liberalizing certain other social service benefits. Petition received and read.
- 3. NATIVE FATALITIES IN NEW BRITAIN—COMMISSION OF INQUIRY—MINISTERIAL STATEMENT.—Mr. Hasluck (Minister for Territories), by leave, made a Ministerial Statement informing the House of the appointment of a Commission to inquire into the circumstances of the deaths of two native villagers and the wounding of one at Navuneram, New Britain, on the 4th August.

Mr. Evatt (Leader of the Opposition), by leave, also made a Statement with reference to the matter.

- 5. Superannuation Bill 1958.—Sir Arthur Fadden (Treasurer) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the Superannuation Act 1922-1957, and for purposes connected therewith.

Question-put and passed.

Sir Arthur Fadden then brought up the Bill accordingly, and moved, That it be now read a first time. Ouestion—put and passed.—Bill read a first time.

Sir Arthur Fadden moved, by leave, That the Bill be now read a second time.

6. Defence Forces Retirement Benefits Bill 1958.—Sir Arthur Fadden (Treasurer) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the *Defence Forces Retirement Benefits*Act 1948-1957, and for purposes connected therewith.

Question-put and passed.

Sir Arthur Fadden then brought up the Bill accordingly, and moved, That it be now read a first time. Question—put and passed.—Bill read a first time.

Sir Arthur Fadden moved, by leave, That the Bill be now read a second time.

- 7. Public Works Committee—Reference of Work—Repatriation General Hospital, Hobart.—Mr. Fairhall (Minister for Works) moved, pursuant to notice, That, in accordance with the provisions of the *Public Works Committee Act* 1913–1953, the following proposed work be referred to the Parliamentary Standing Committee on Public Works for investigation and report, namely:—Construction of Extensions to the Repatriation General Hospital at Hobart, Tasmania.

Mr. Fairhall laid on the Table plans in connexion with the proposed work.

Question—put and passed.

8. Christmas Island Bill 1958.—Mr. Hasluck (Minister for Territories) moved, by leave, That he have leave to bring in a Bill for an Act to provide for the Acceptance of Christmas Island as a Territory under the Authority of the Commonwealth and to provide for the Government of that Territory. Question—put and passed.

Mr. Hasluck then brought up the Bill accordingly, and moved, That it be now read a first time.

Question-put and passed.-Bill read a first time.

Mr. Hasluck moved, by leave, That the Bill be now read a second time.

Debate adjourned (Mr. C. R. Cameron), and the resumption of the debate made an Order of the Day for the next sitting.
