## WEDNESDAY, 22ND APRIL, 1959.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.
- 2. PETITION.—Mr. Daly presented a Petition from certain citizens of Australia praying that the House will (1) give immediate consideration to the matter of increasing the rate of age, invalid and widows' pensions to at least 50 per cent. of the basic wage, (2) amend the National Health Act to make the Pensioner Medical Service available to all pensioners irrespective of means, and (3) provide increased pharmaceutical benefits for pensioners. Petition received and read.
