5. DISCUSSION OF MATTER OF URGENCY—UNEMPLOYMENT IN COAL MINING AREAS.—Mr. Speaker informed the House that Mr. Luchetti had proposed that a definite matter of urgent public importance be submitted to the House for discussion, namely, "The failure of the Government to deal with the persisting problem of unemployment in coal mining areas throughout Australia which causes avoidable hardship to miners, tradespeople and the community generally resident in such areas ".

The proposed discussion having received the necessary support-

Mr. Luchetti addressed the House.

Discussion ensued.

The discussion having been continued for two hours, it was terminated in accordance with Standing Order No. 92.

6. INTERNATIONAL MONETARY AGREEMENTS BILL 1959.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-

(In the Committee.)

Progress to be reported, and leave asked to sit again.

The House resumed: Mr. Bowden reported accordingly.

Ordered—That the House will, at a later hour this day, again resolve itself into the said Committee.

7. Message from the Governor-General—International Monetary Agreements Bill 1959.—Mr. Speaker announced the receipt of the following Message from His Excellency the Governor-General:—

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act relating to a proposed adjustment of the Quotas of members of the International Monetary Fund and to a proposed increase of the Capital Stock of the International Bank for Reconstruction and Development.

Mr. Holt (Treasurer) moved, That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act relating to a proposed adjustment of the Quotas of members of the International Monetary Fund and to a proposed increase of the Capital Stock of the International Bank for Reconstruction and Development.

Question-put and passed.

Resolution to be reported.

The House resumed; Mr. Bowden reported accordingly.

On the motion of Mr. Holt, the Resolution reported from the Committee was adopted by the House.

8. INTERNATIONAL MONETARY AGREEMENTS BILL 1959.—The House, according to Order, again resolved itself into a Committee of the Whole for the further consideration of the Bill.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Bowden reported accordingly.

On the motion of Mr. Holt (Treasurer), the House adopted the Report.

Mr. Holt moved, by leave, That the Bill be now read a third time.

Debate ensued.

Question—put and passed.—Bill read a third time.

9. Message from the Governor-General-Commonwealth Aid Roads Bill 1959.--Mr. Speaker announced the receipt of the following Message from His Excellency the Governor-General:-

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to grant Financial Assistance to the States in relation to Roads and to Works connected with Transport.

Canberra, 28th April, 1959.

Ordered-That the Message be taken into consideration, in Committee of the whole House, forthwith.

(In the Committee.)

Mr. Holt (Treasurer) moved, That it is expedient than an appropriation of revenue be made for the purposes of a Bill for an Act to grant Financial Assistance to the States in relation to Roads and to Works connected with Transport. Question—put and passed.

Resolution to be reported.

The House resumed; Mr. Bowden reported accordingly.

Mr. Holt moved, pursuant to contingent notice, That so much of the Standing Orders be suspended as would prevent the remaining stages being passed without delay.

Question—put and passed.

On the motion of Mr. Holt, the Resolution reported from the Committee was adopted by the House. Ordered—That Mr. Holt and Mr. Hasluck do prepare and bring in a Bill to carry out the foregoing Resolution.

Bill brought up by Mr. Holt, and read a first time.

Mr. Holt moved, That the Bill be now read a second time.

Debate adjourned (Mr. Crean), and the resumption of the debate made an Order of the Day for the next sitting.

 ADJOURNMENT.—Mr. Holt (Treasurer) moved, That the House do now adjourn. Question—put and passed.

And then the House, at twenty-six minutes past ten o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
