- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.
- 2. Petitions.—Mr. Thompson presented a Petition from certain electors in the States of the Commonwealth praying that the House will take immediate steps to increase social service benefits for mothers and their children.
 - Mr. Curtin presented a Petition from certain citizens of Australia praying that the House will (1) give immediate consideration to the matter of increasing the rate of age, invalid and widows' pensions to at least 50 per cent. of the basic wage, (2) amend the National Health Act to make the Pensioner Medical Service available to all pensioners irrespective of means, and (3) provide increased pharmaceutical benefits for pensioners.

Petitions severally received and read.

- 3. SHIPPING SERVICE TO TASMANIA-MINISTERIAL STATEMENT, -- Mr. Hulme (Minister representing the Minister for Shipping and Transport), by leave, made a Ministerial Statement regarding a suggestion that the steamer Taroona should be kept in service on the Tasmanian run next season in addition to the new vehicle-carrying ferry Princess of Tasmania.

Debate resumed by Mr. Bird who moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof:--" the Bill be withdrawn and redrafted with a view to providing that without reduction of the amounts provided under this Bill, an amount of money not less than the full proceeds of the petrol and diesel fuel taxes shall be granted to the States for expenditure by the States, municipalities and shires on or in connexion with roads".

Debate continued. Debate adjourned (Mr. Duthie), and the resumption of the debate made an Order of the Day for the next sitting.
