- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.
- 2. Petitions.—Mr. Kearney presented a Petition from certain citizens of Australia praying that the House will (1) give immediate consideration to the matter of increasing the rate of age, invalid and widows' pensions to at least 50 per cent. of the basic wage, (2) amend the National Health Act to make the Pensioner Medical Service available to all pensioners irrespective of means, and (3) provide increased pharmaceutical benefits for pensioners.

Petition received and read.

A similiar Petition was presented by Mr. Clay, and was received.

Mr. Courtnay presented a Petition from certain citizens of Australia praying that immediate consideration be given to the matter of increasing the rate of age, invalid and widows' pensions to at least 50 per cent. of the basic wage.

Petition received and read.

Similar Petitions were presented by Mr. McColm and Mr. Clark, and were severally received.

4. Advance to the Treasurer 1958-59—Statement of Expenditure.—Mr. Holt (Treasurer), by command of His Excellency the Governor-General, laid upon the Table the following Paper:—

Statement for the year 1958-59 of Heads of Expenditure and the Amounts charged thereto pursuant to Section 36A of the *Audit Act* 1901-1959 (Advance to the Treasurer).

5. DISCUSSION OF MATTER OF URGENCY—COMMONWEALTH LITERARY FUND.—Mr. Speaker informed the House that Mr. Haylen had proposed that a definite matter of urgent public importance be submitted to the House for discussion, namely, "The failure of the Government to enlarge the authority controlling the Commonwealth Literary Fund into a Commonwealth Literary Commission, on the lines of the Canadian Literary Commission, with an annual grant of £100,000 a year, instead of £12,000 a year, so that adequate provision for scholarships, literary pensions and the sponsorship of publications of Australian writers can be made".

The proposed discussion having received the necessary support-
