Fraser, viz.:—That all words after "That" be omitted with a view to inserting the following words in place thereof:—"the Bill be withdrawn and re-drafted to provide rates of social service payments adequate to present living costs and representing a fair and reasonable share of the national income, such rates to take effect from the first pension pay day in July "—
