- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.
- 2. DISTINGUISHED VISITOR.—Mr. Speaker informed the House that the Right Honorable Peter Thorneycroft, M.P., Minister for Aviation in the Government of the United Kingdom, was within the precincts. The distinguished visitor thereupon, with the concurrence of honorable Members, was provided with a seat on the floor of the House.
- 3. MINISTERIAL ARRANGEMENTS.—Mr. Menzies (Prime Minister) informed the House that, during the absence abroad of Sir Garfield Barwick, Mr. McMahon (Minister for Labour and National Service) would act as Attorney-General and would represent in this House the Minister for National Development.
- 4. INDUS WATERS AGREEMENTS—MINISTERIAL STATEMENT.—Mr. Menzies (Minister for External Affairs), by leave, made a Ministerial Statement with reference to the Indus Waters Treaty and the Indus Basin Development Fund Agreement, signed in Karachi on the 19th September, 1960, and informed the House of the contribution proposed to be made by Australia under the Agreement. Mr. Menzies also informed the House that he had forwarded messages of congratulation to the Prime Minister of India and the President of Pakistan on the signing of the Treaty.

Mr. Calwell (Leader of the Opposition), by leave, also made a Statement with reference to the Agreements and associated the Opposition with the messages of congratulation.

Debate adjourned (Mr. Duthie), and the resumption of the debate made an Order of the Day for the next sitting.

8. ADJOURNMENT.—Mr. Downer (Minister for Immigration) moved, That the House do now adjourn. Question—put and passed.

And then the House, at four minutes to eleven o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
