- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.
- 2. PRIME MINISTER—ATTENDANCE AT GENERAL ASSEMBLY OF UNITED NATIONS.—Mr. Menzies (Prime Minister) informed the House that he proposed to make a quick journey to attend the current meeting of the General Assembly of the United Nations.
- 3. AUSTRALIAN NATIONAL UNIVERSITY—APPOINTMENTS TO COUNCIL—MINISTERIAL STATEMENT.—Mr. Downer (Minister for Immigration), by leave, made a Ministerial Statement informing the House of the persons who had been appointed by His Excellency the Governor-General to the Council of the Australian National University for a period of three years from the 30th September, 1960.
- 4. PAPERS—MINISTERIAL STATEMENT.—The following Paper was presented, by command of His Excellency the Governor-General—

National Radiation Advisory Committee—Third Annual Report, July, 1960. Ordered to be printed.


