- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.-Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.
- 2. SUSPENSION OF STANDING ORDERS-PRECEDENCE TO BUSINESS.-Mr. Holt (Treasurer) moved, by leave, That, during the consideration of the Want of Confidence Motion, so much of the Standing Orders be suspended as would prevent the House proceeding each day with the items of business numbered 1 to 5 in Standing Order No. 102. Question-put and passed.

- 4. WANT OF CONFIDENCE IN THE GOVERNMENT.-Mr. Calwell (Leader of the Opposition) moved, pursuant to notice, That because the Government's rapidly changing plans have failed to protect and develop the Australian economy and to safeguard our overseas funds and have caused grave confusion, dislocation and hardship to many sections of industry, both primary and secondary, and unnecessary suffering to many citizens, particularly those who have lost their employment, this Government does not possess the confidence of the Parliament or of the Nation. Debate ensued.

Debate adjourned (Mr. Pearce), and the resumption of the debate made an Order of the Day for the next sitting.
