TUESDAY, 9TH MAY, 1961.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.
- 2. Sixtieth Anniversary of Opening of First Commonwealth Parliament.—Mr. Menzies (Prime Minister) reminded the House that this day marked the sixtieth anniversary of the opening of the first Commonwealth Parliament on the 9th May, 1901, and the thirty-fourth anniversary of the opening of the present Parliamentary building. Mr. Menzies referred to Australia's growth and development over the past sixty years and added that, over that period, the Parliament had been preserved and strengthened as a free and truly democratic institution.

Mr. Calwell (Leader of the Opposition) associated the Opposition with the remarks of the Prime Minister.

- 3. Petition.—Mr. J. R. Fraser presented a Petition from certain citizens of the Australian Capital Territory praying that the Government will take immediate action to defer the rental increases on Government-owned dwellings in Canberra and immediately promote an inquiry into rentals in relation to costs of living in Canberra and the need for the establishment of a Canberra Basic Wage. Petition received.
- 4. CIVIL AVIATION RELATIONS BETWEEN AUSTRALIA AND NEW ZEALAND—MINISTERIAL STATEMENT.—Mr. Townley (Minister representing the Minister for Civil Aviation), by leave, made a Ministerial Statement relating to the sale of Australia's half share in Tasman Empire Airways Limited to the New Zealand Government and to new arrangements for civil aviation operations between Australia and New Zealand.
