TUESDAY, 12TH SEPTEMBER, 1961.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.-Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.
- 2. DEATH OF SENATOR R. W. PEARSON .--- Mr. Menzies (Prime Minister) referred to the death, on the 11th September, of Senator R. W. Pearson, and moved, That this House expresses its deep regret at the death of Rex Whiting Pearson, a Senator from the State of South Australia, places on record its appreciation of his long and meritorious public service and tenders its profound sympathy to his family in its bereavement.

And Mr. Calwell (Leader of the Opposition) having seconded the motion, and Mr. McEwen (Minister for Trade) and Mr. Forbes having addressed the House in support thereof, and all Members present having risen, in silence-Question-passed.

- 3. SUSPENSION OF SITTING AS MARK OF RESPECT .- As a mark of respect to the memory of the deceased Senator, the sitting was thereupon suspended until eight o'clock p.m.
- 4. RESUMPTION OF SITTING .- At eight o'clock p.m., Mr. Speaker resumed the Chair.
- 5. GENERAL ELECTIONS-MINISTERIAL STATEMENT.-Mr. Menzies (Prime Minister), by leave, made a Ministerial Statement informing the House of the dates in connexion with the General Elections for the House of Representatives to be held on the 9th December.

- 7. STATEMENT BY MEMBER.—Mr. Duthie, by leave, made a Statement with reference to an accusation, made by the Leader of the Australian Democratic Labor Party, that he had formerly been a member of the Communist Party.
- 8. POSTPONEMENT OF ORDERS OF THE DAY.—Ordered—That Orders of the Day Nos. 1 and 2 be postponed until after Order of the Day No. 3, Government Business.
- 9. SOCIAL SERVICES BILL 1961.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—

Debate resumed by Mr. A. D. Fraser who moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof:—" this House condemns the Government for having failed to increase rates of payment of various social services to correspond with increased prices, and particularly condemns the Government for again refusing to make any increase in child endowment, thus leaving child endowment unaltered since 1950, during which time its purchasing value has halved". Debate continued.
