Post Office—Illegal Betting—Ministerial Statement—Motion for Printing Paper.—Mr. Davidson (Postmaster-General), by leave, made a Ministerial Statement with reference to co-operation extended by the Post Office to State Police authorities in suppressing illegal betting and referred to allegations that some Post Office employees in Victoria were not collaborating with the Police in that State. Mr. Davidson then, by command of His Excellency the Governor-General, laid upon the Table the following Paper:-
