THURSDAY, 9TH MAY, 1963.

- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. QUESTIONS.—Questions without notice were answered.
- 3. PAPER.—The following Paper was presented, pursuant to Statute— Lands Acquisition Act-Land acquired for postal purposes-Thomastown, Victoria.
- 4. DISABLED PERSONS HOMES BILL 1963.—Mr. A. D. Fraser moved, pursuant to notice, That he have leave to bring in a Bill for an Act to make available to Disabled Persons the Benefits provided for Aged Persons under the Aged Persons Homes Act.

Debate ensued.

- It being two hours after the time fixed for the meeting of the House, the debate was interrupted in accordance with Standing Order No. 108, Mr. Roberton (Minister for Social Services) was granted leave to continue his speech when the debate is resumed, and the resumption of the debate was made an Order of the Day for the next sitting.
- 5. Suspension of Standing Orders—Statement by Member.—Mr. Holt (Treasurer) moved, That so much of the Standing Orders be suspended as would prevent Mr. A. D. Fraser making a statement not exceeding fifteen minutes on the subject of homes for disabled persons. Question—put and passed, with the concurrence of an absolute majority.

(b) in the case of an Ordinance, or part of an Ordinance, deemed to have been disallowed the House of the Parliament in which notice of the resolution to disallow that Ordinance or part was given approves, by resolution, the making of a provision the same in substance as the provision deemed to have been disallowed."
