1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.

2. QUESTIONS.—Questions without notice were answered.

- 3. PAPERS.—The following Papers were presented, pursuant to statute—
 - Apple and Pear Organization Act—Australian Apple and Pear Board—Seventeenth Annual Report, for year 1962–63, together with Statement by Minister regarding the operation of the Act.
 - Science and Industry Endowment Act—Report by Auditor-General on Accounts of Science and Industry Endowment Fund, for year 1962-63.
 - Snowy Mountains Hydro-electric Power Act—Snowy Mountains Hydro-electric Authority— Fourteenth Annual Report and financial statements, together with the Auditor-General's Report, for year 1962-63.
 - Wine Overseas Marketing Act—Australian Wine Board—Thirty-fifth Annual Report, for year 1962–63, together with Statement by Minister regarding the operation of the Act.
- SPECIAL ADJOURNMENT.—Mr. Hasluck (Minister for Territories) moved, That the House, at its rising, adjourn until Tuesday, the 8th October, at half-past two o'clock p.m. Question—put and passed.
- 5. SELECT COMMITTEE ON HOUSE OF REPRESENTATIVES ACCOMMODATION.—Mr. Wentworth moved, pursuant to notice—
 - (1) That a Select Committee be appointed to consider the adequacy or inadequacy of the accommodation available for Members and Ministers and their staffs on the House of Representatives side of the present Parliament House and to make recommendations in relation thereto.
 - (2) That the Committee consist of the mover and six other members.
 - (3) That there be a Deputy Chairman of the Committee.
 - (4) That of the six members other than the mover, three be appointed by the Prime Minister and three be appointed by the Leader of the Opposition.
 - (5) That from the seven members of the Committee, the Prime Minister appoint the Chairman and the Leader of the Opposition appoint the Deputy Chairman.
 - (6) That every appointment be forthwith notified in writing to the Speaker.
 - (7) That any member of the Committee have power to add a protest or dissent to the report of the Committee.
 - (8) That the Committee have power to send for persons, papers and records and to sit during any adjournment of the House and during the sittings of the House.
 - (9) That the Committee report to the House as soon as possible.
 - (10) That the foregoing provisions of this resolution, so far as they are inconsistent with the Standing Orders, have effect notwithstanding anything contained in the Standing Orders.

Debate ensued.

Question-put and passed.

- 6. SOUTH-EAST ASIA.—Sir Wilfrid Kent Hughes moved, pursuant to notice, That in view of the increasing pressure of Communist infiltration, subversion and guerilla aggression in South-East Asia, this House is of the opinion that, in order to strengthen the security of Australia, and South-East Asian countries who may desire assistance—
 - (i) Australia should confer with South-East Asian nations on the advisability of establishing a Planning Headquarters to guarantee the security of South-East Asia.
 - (ii) SEATO should be reorganized on a wider basis such as South-East Asia and Western Pacific Treaty Organization, and
 - (iii) in co-operation with South-East Asian nations an Economic Planning Headquarters should be established to co-ordinate and speed up economic developmental projects such as the Mekong River Plan, and also to assist the association of South-East Asian nations in their marketing problems.

NATIONAL SERVICE TRAINING.—The Order of the Day having been read for the resumption of the debate on the following motion of Sir Wilfrid Kent Hughes, That in view of the increasing pressure of Communist infiltration, subversion and guerilla aggression in South-East Asia, this House is of the opinion that, in order to strengthen the security of Australia, and South-East Asian countries who may desire assistance—
 - (i) National Service Training should be introduced on the basis of a minimum of twelve months continuous service, and
 - (ii) if it is considered advisable to establish such National Service Training on a selective basis, then rehabilitation benefits should be granted on similar, but not necessarily the same, lines as in the United States of America—
