PETITION .--- Mr. Courtnay presented a Petition from certain citizens of the Commonwealth praying that the Government remove section 127, and the words discriminating against Aborigines in section 51, of the Commonwealth Constitution, by the holding of a referendum at an early date. Petition received.
- 3. QUESTIONS.—Questions without notice were answered.
- 4. GRIEVANCES OF YIRRKALA ABORIGINES, ARNHEM LAND RESERVE-SELECT COMMITTEE-REPORT-STATEMENT BY MEMBER.-Mr. Dean (Chairman) brought up the Report from the Select Committee on Grievances of Yirrkala Aborigines, Arnhem Land Reserve, together with the Minutes of Proceedings of the Committee and Minutes of Evidence. Ordered to be printed.

Mr. Dean, by leave, made a Statement with reference to the Report.

Mr. Calwell (Leader of the Opposition) moved the following amendment:—Clause 4, page 2, at the end of proposed section 105B add the following sub-section:—

" (5.) An application for a licence for a television translator station shall be referred by the Minister to the Board. The Board shall give notice of receipt of the application in such newspapers and by such other means as the Board thinks fit and shall give notice in writing of such application to all licensees of commercial television stations operating within a radius of 200 miles from the site of the proposed television translator station and to such other persons as the Board thinks fit. If notice of objection to the granting of the application is lodged with the Board by a person interested within fourteen days after the giving of such notices the Board shall not recommend that the application be granted if the Board is of opinion that the television translator station would operate so as to prevent or to be likely to prevent the establishment of a commercial television station in or about the area to which the application relates or to be unfair to the licensee of any other commercial television station.".

Amendment negatived.

Bill agreed to.

"4. The payments by the Commonwealth to the State of New South Wales Financial assistance. provided for by the agreement referred to in the last preceding section may be made, by way of financial assistance to that State on the terms and conditions contained in that agreement, out of the Consolidated Revenue Fund, which is appropriated accordingly.".

Bill, as amended, agreed to. Bill to be reported with an amendment.

The House resumed; Mr. Mackinnon reported accordingly. On the motion of Mr. Fairbairn, by leave, the House adopted the Report, and, by leave, the Bill was read a third time.
