- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. Petition.—Mr. Benson presented a Petition from certain electors of the Commonwealth praying that the Commonwealth Government immediately grant a basic pension rate of £8 10s. per week, formulate a national housing plan for low rental homes for pensioners and provide all pensioners within the permissible income with the medical entitlement card. Petition received and read.

3. QUESTIONS.—Questions without notice were asked.

4. PAPERS.—The following papers were presented, by command of His Excellency the Governor-General— Air Services-

Agreement between Malaysia and Australia, signed 19th March, 1964.

Statement, dated 7th April, 1964, by Minister for Civil Aviation on Agreements with Malaysia and Italy.

5. DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—WELFARE OF ABORIGINES.—Mr. Speaker informed the House that Mr. Beazley had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The need for all Commonwealth instrumentalities, including the armed services, to pay Aborigines employed by them a wage at least equivalent to the award rate as fixed by the Arbitration Commission for a worker similarly employed who is covered by awards; the need for the extension of the protection of Arbitration Commission awards to Aborigines employed privately in the Northern Territory; the need for unemployment, sickness and tuberculosis benefits to be paid to Aborigines in the Northern Territory at the same rate as for other citizens and to be as readily available to them".

The proposed discussion having received the necessary support—

Mr. Beazley addressed the House.

Discussion ensued.

Discussion concluded.

6. Customs Tariff Proposals Nos. 7 and 8 and Customs Tailiff (Papua and New Guinea Preference) Proposals No. 2.—Mr. Fairhall (Minister representing the Minister for Customs and Excise) moved-Customs Tariff Proposals Nos. 7 and 8; and

- Debate adjourned (Mr. Crean), and the resumption of the debate made an order of the day for the next sitting.
- 7. PAPER.—The following paper was presented, by command of His Excellency the Governor-General— Tariff Board-Report-P.V.C. products. Ordered to be printed.
- 8. MEAT INDUSTRY BILL 1964.-The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time-Debate resumed.

Question—put and passed.—Bill read a second time.

Message from the Governor-General.—Mr. Speaker announced the receipt of message No. 7, dated 7th April, 1964, from His Excellency the Governor-General recommending an appropriation of revenue for the purposes of the Bill.
