TUESDAY, 19TH MAY, 1964.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. Petitions.—Petitions from certain electors of the Commonwealth praying that the Commonwealth Government immediately grant a basic pension rate of £8 10s. per week, formulate a national housing plan for low rental homes for pensioners and provide all pensioners within the permissible income with the medical entitlement card were presented by Mr. Davis and Mr. Clark.

 Petitions severally received.
- 3. Business of the House.—Mr. Holt (Treasurer), by leave, informed the House of the intention of the Government to arrange for consideration by the House to-morrow of the motion of which notice had been given this day by the Leader of the Opposition.
- 4. MINISTERIAL ARRANGEMENTS.—Sir Robert Menzies (Prime Minister) informed the House that, during the absence abroad of Mr. Adermann, Senator Wade (Minister for Health) would act as Minister for Primary Industry and be represented in this House by Mr. McEwen (Minister for Trade). Sir Robert Menzies also informed the House that, during the impending absence abroad of Mr. McMahon, Mr. Freeth (Minister for Shipping and Transport) would act as Minister for Labour and National Service.
- 5. QUESTIONS.—Questions without notice were asked.

- ALTERATION OF HOUR OF NEXT MEETING.—Mr. Hasluck (Minister for External Affairs) moved, That the House, at its rising, adjourn until half-past ten o'clock a.m. to-morrow.
 Ouestion—put and passed.
- 11. Explosives BILL 1964.—Mr. Freeth (Minister for Shipping and Transport), by leave, presented a Bill for an Act to amend the Explosives Act 1961.

Bill read a first time.

Mr. Freeth moved, That the Bill be now read a second time.

Debate adjourned (Mr. Galvin), and the resumption of the debate made an order of the day for the next sitting.

- 12. States Grants (Science Laboratories and Technical Training) Bill 1964.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time—And on the amendment moved thereto by Mr. Calwell, viz.:—That all words after "That" be omitted with a view to inserting the following words in place thereof:—"the Bill is an inadequate contribution to science education and to education generally in Australia because it—
 - (1) fails to provide for an inquiry into all aspects of education, at all levels, as requested on several occasions by States Premiers;
 - (2) fails to meet the crisis in education by making an emergency grant of at least £10 million to the States;
 - (3) fails to assist parents of all children at all schools to bear the burden of education from primary to tertiary levels by instituting a system of Commonwealth scholarships for all students capable of receiving an education, such scholarships to be tenable at the schools of the parents' choice;
 - (4) fails to attack the problem of science education by ignoring the question of teacher training, and the need for the establishment of a national science foundation to co-ordinate scientific training, teaching and research; and

(5) fails to recognize that all pupils are entitled to be educated to the fullest extent of their abilities on the principle of aid to the scholar without discrimination "—

Debate resumed.

Question—That the words proposed to be omitted stand part of the question—put.

Debate resumed.

Question—put and passed.—Bills together read a second time.

Leave granted for third readings to be moved forthwith.

On the motion of Mr. Snedden (Attorney-General), the Bills were together read a third time.

18. INCOME TAX AND SOCIAL SERVICES CONTRIBUTION ASSESSMENT BILL 1964.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time-Debate resumed.

Question-put and passed.-Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr. Roberton (Minister for Social Services), the Bill was read a third time.

19. Homes Savings Grant Bill 1964.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time-Debate resumed.

Question—put and passed.—Bill read a second time.

Clauses 1 to 13, by leave, taken together, and agreed to.

Clause 14-

Mr. Bate moved the following amendment:—Page 7, omit paragraph (d).

Point of order.--Mr. Bury (Minister for Housing) raised a point of order that the amendment was out of order as its effect would be to increase the appropriation recommended by the Governor-General. Chairman's ruling.—The Chairman (Mr. Lucock) upheld the point of order for the reason stated.

19th and 20th May, 1964.

Debate continued.

Mr. Bate moved, That the clause be postponed.

Question-put and negatived.

Clause agreed to.

Clause 15 agreed to.

Clause 16-

On the motion of Mr. Bury, the following amendment was made:—Pages 9 and 10, omit sub-clause (3.), insert the following sub-clause:—

"(3.) For the purposes of this Act, the acceptable savings of a person to whom this section applies as at a time (in this sub-section referred to as 'the relevant time') after the thirty-first day of December, One thousand nine hundred and sixty-four, and on or before the thirty-first day of December, One thousand nine hundred and sixty-seven, are, subject to this Act, the moneys that were saved in Australia before the relevant time by the person and—

(a) in the case of moneys saved before the first day of January, One thousand nine hundred and sixty-five—

(i) were maintained at that date and at the relevant time by the person, or by the person jointly with his or her spouse, on deposit with a branch in Australia of a savings bank or of a trading bank;

(ii) were maintained at that date and at the relevant time by the person, or by the person jointly with his or her spouse, on deposit with a building society, friendly society or credit union: or

(iii) were paid before that date by the person or his or her spouse, or by both of those persons, to a building society as subscriptions in respect of shares in the capital of the society and were not repaid before the relevant time; or

(b) in the case of moneys saved on or after the first day of January, One thousand nine hundred and sixty-five—

- (i) were maintained at the relevant time by the person, or by the person jointly with his or her spouse, on deposit with a branch in Australia of a savings bank or on fixed deposit with a branch in Australia of a trading bank, being a deposit that was described in the books or records of the savings bank or the trading bank, as the case may be, as a Home Savings Account;
- (ii) were maintained at the relevant time by the person, or by the person jointly with his or her spouse, on deposit with a building society; or
- (iii) were paid before the relevant time by the person or his or her spouse, or by both of those persons, to a building society as subscriptions in respect of shares in the capital of the society and were not repaid before the relevant time.".

Clause, as amended, agreed to.

Clauses 17 to 19, by leave, taken together, and agreed to.

Clause 20—

Mr. Bate moved the following amendment:—Page 12, after sub-clause (1.) insert the following sub-clause:—

"(1A.) The Secretary may, in his discretion, give to a person a certificate in writing certifying that, if the person enters into a contract on a specified date for the purchase of a specified dwelling-house situated in Australia or for the construction by a building-contractor of a dwelling-house on specified land situated in Australia and the provisions of this Act are otherwise applicable to him on that date, he will be eligible for a grant under this Act of a specified amount."

Debate ensued.

Amendment negatived.

Clause agreed to.

Clause 21—

Mr. Bate moved the following amendment:—Page 15, after sub-clause (1.) insert the following sub-clause:—

"(1A.) Where an applicant for a grant under this Act furnishes to the Secretary with the application a declaration in writing stating any facts relating to the amount of the acceptable savings of the person or of his or her spouse as at a specified time, the Secretary shall treat the declaration as evidence of those facts unless he has reasonable cause to believe that the declaration does not correctly state those facts."

Debate ensued.

Amendment negatived.

Clause agreed to.

Clause 22—

On the motion of Mr. Bury, the following amendment was made:—Page 17, after sub-clause (8.) insert the following sub-clause:—

"(8A.) A reference in paragraph (a) of the last preceding sub-section to a savings year shall be read as a reference to a savings year commencing on or after the first day of January, One thousand nine hundred and sixty-five, and not to any other savings year."

Clause, as amended, agreed to.

Clauses 23 to 31, by leave, taken together, and agreed to.

Clause 32—

On the motion of Mr. Bury, the following amendment was made, after debate:—Page 20, at the end of the clause add the following sub-clause:—

"(3.) The first report under this section shall be furnished as soon as practicable after the thirtieth day of June, One thousand nine hundred and sixty-five, and shall relate to the period commencing on the date of commencement of this Act and ending on that thirtieth day of June.". Clause, as amended, agreed to.

Clause 33 agreed to.

Title agreed to.

Bill to be reported with amendments.

The House resumed; Mr. Lucock reported accordingly.

On the motion of Mr. Bury, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

- 23. SULPHATE OF AMMONIA BOUNTY BILL 1964. -- Mr. Fairhall (Minister representing the Minister for Customs and Excise) presented a Bill for an Act to amend the Sulphate of Ammonia Bounty Act 1962. Bill read a first time.

Mr. Fairhall moved, That the Bill be now read a second time.

Debate adjourned (Mr. Pollard), and the resumption of the debate made an order of the day for a later hour this day.
