Public Works Committee—Re-submission of Work—Road from Top Springs to Wave Hill, Northern Territory.—Mr. Freeth (Minister representing the Minister for Works) moved, pursuant to notice, That, in accordance with the provisions of the *Public Works Committee Act* 1913–1960, the following proposed work, on which the Parliamentary Standing Committee on Public Works has duly reported to this House, be remitted to the committee for their furthe: consideration and report:—Construction of the Top Springs to Wave Hill Road, Northern Territory.

Mr. Freeth presented plans of the revised proposed work.

Question-put and passed.

6. APPROPRIATION BILL 1964-65—BUDGET DEBATE.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time—And on the amendment moved thereto by Mr. Calwell, viz.:—That all words after "That" be omitted with a view to inserting the following words in place thereof:—"the House is of opinion that the Budget does not adequately grapple with the problems of striking a realistic and fitting balance between the claims on national resources arising from defence, development and social welfare"—

Debate adjourned (Mr. Forbes—Minister for the Army), and the resumption of the debate made an order of the day for the next sitting.
