- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. QUESTIONS.—Questions without notice were asked.
- 3. PRINTING COMMITTEE-FOURTH REPORT.-Mr. G. D. Erwin (Chairman) brought up the Fourth Report from the Printing Committee (sitting in conference with the Printing Committee of the Senate). The report was read by the Acting Clerk, as follows:-

FOURTH REPORT.

The Printing Committee has the honour to report that it has met in Conference with the Printing Committee of the Senate.

The Joint Committee, having considered the Petitions and Papers presented to Parliament since the last meeting of the Committee, and certain other Papers not formerly considered by the Committee, recommends that the following be printed:-

Mr. Erwin moved, by leave, That the report be agreed to. Question-put and passed.

- 4. Special Adjournment.—Mr. Adermann (Minister for Primary Industry) moved, That the House, at its rising, adjourn until Monday, the 9th November, at half-past two o'clock p.m. Question-put and passed.
- 5. REPRESENTATION BILL 1964.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time-

Debate resumed by Mr. Calwell (Leader of the Opposition) who moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof:- "this House is of opinion that a decision on the proposal contained in the Bill should be deferred until the Government introduces other electoral legislation announced in the Governor-General's Opening Speech".

Debate continued.

Amendment amended by Mr. Calwell, by leave, by adding the following words to the words proposed to be inserted:—" and until the people have been given an opportunity to vote at a referendum on the Constitutional Review Committee's proposals on Commonwealth legislative machinery".

Debate continued.

Amendment negatived.

Ouestion—put and passed.—Bill read a second time.

The House resolved itself into a committee of the whole.

(In the committee.)

Bill, by leave, taken as a whole, and agreed to, after debate.

Bill to be reported without amendment.

The House resumed; Mr. Mackinnon reported accordingly.

On the motion of Mr. Anthony (Minister for the Interior), the House adopted the report. Mr. Anthony moved, by leave, That the Bill be now read a third time.

Debate ensued.

Question—put and passed.—Bill read a third time.

7. AIR NAVIGATION (CHARGES) BILL 1964.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time-

Debate resumed.

Question-put and passed.-Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr. Fairbairn (Minister representing the Minister for Civil Aviation), the Bill was read a third time.

- 8. SUSPENSION OF STANDING ORDERS-TARIFF BILLS .- Mr. Bury (Minister representing the Minister for Customs and Excise) moved, by leave, That so much of the standing orders be suspended as would prevent three Tariff Bills-
 - (a) being presented and read a first time together and one motion being moved without delay and one question being put in regard to, respectively, the second readings, the committee's report stage, and the third readings, of all the Bills together, and
 - (b) the consideration of the Bills separately in one committee of the whole.

Question—put and passed.

9. CUSTOMS TARIFF (No. 4), CUSTOMS TARIFF (New Zealand Preference) (No. 4) and Excise Tariff Bills 1964.—Mr. Bury (Minister representing the Minister for Customs and Excise) presented the following Bills:-

A Bill for an Act relating to Duties of Customs;

A Bill for an Act to amend the Customs Tariff (New Zealand Preference) 1933-1963, as amended by the Customs Tariff (New Zealand Preference) (No. 1) 1964, by the Customs Tariff (New Zealand Preference) (No. 2) 1964 and by the Customs Tariff (New Zealand Preference) (No. 3) 1964; and

A Bill for an Act relating to Duties of Excise.

Bills together read a first time.

Mr. Bury moved, That the Bills be now read a second time.

Debate adjourned (Mr. J. F. Cairns), and the resumption of the debate made an order of the day for the next sitting.

10. ADJOURNMENT.-Mr. Bury (Minister for Housing) moved, That the House do now adjourn. Debate ensued.
