SCHEDULE OF A REQUEST BY THE SENATE FOR AN AMENDMENT.

Page 1, clause 4, sub-clause (1.), line 21, after " advertisement " add ", provided that if the licensee satisfies the Minister that any such earnings have been received in connection with the televising of, or the provision by him of, musical, dramatic or other artistic material wholly produced or originating in Australia, as defined by the Australian Broadcasting Control Board in its categories of programmes, then only one-half of those earnings shall be included in the gross earnings of the station ". Mr. Hulme (Postmaster-General) moved, That the requested amendment be not made.

Debate ensued.

Mr. Wentworth moved, as an amendment, That the word " not " be omitted from the motion.
