- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. QUESTIONS.—Questions without notice were asked.
- 3. Commonwealth Superannuation Fund—Disposal of Surplus—Ministerial Statement—Motion to Take note of Paper.—Mr. Holt (Treasurer), by leave, made a ministerial statement informing the House of the decisions reached by the Government regarding the disposal of the surplus in the Commonwealth Superannuation Fund revealed at the Eighth Quinquennial Investigation of the Fund, and, by command of His Excellency the Governor-General, presented the following paper:—

Commonwealth Superannuation Fund—Disposal of Surplus—Ministerial statement, 25th March,

and moved, That the House take note of the paper.

Debate adjourned (Mr. Crean), and the resumption of the debate made an order of the day for the next sitting.

- 4. Re-establishment Charter for National Servicemen—Ministerial Statement.—Mr. McMahon (Minister for Labour and National Service), by leave, made a ministerial statement informing the House of arrangements which would come within a re-establishment charter which the Government had decided would be applied to national servicemen.
- 5. Overseas Visit by Minister for Defence—Ministerial Statement—Motion to take note of Paper.—Mr. Fairhall (Minister representing the Minister for Defence), by leave, made a ministerial statement with reference to the recent visit to South East Asia and the United States of America by the Minister for Defence, and, by command of His Excellency the Governor-General, presented the following paper:—

Debate adjourned (Mr. Crean), and the resumption of the debate made an order of the day for the next sitting.

8. Homes Savings Grant Bill 1965.—Mr. Bury (Minister for Housing), pursuant to notice, presented a Bill for an Act to amend the *Homes Savings Grant Act* 1964.

Bill read a first time.

Mr. Bury moved, That the Bill be now read a second time.

Debate adjourned (Mr. Whitlam), and the resumption of the debate made an order of the day for the next sitting.
