- 1. The House met, at three o'clock p.m., according to the terms of the Resolution of the 26th May last.— Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. APPOINTMENT OF LORD CASEY AS GOVERNOR-GENERAL.—Sir Robert Menzies (Prime Minister) informed the House that Her Majesty the Queen had been graciously pleased to approve the appointment of the Right Honorable Lord Casey, P.C., C.H., D.S.O., M.C., K.St.J., as Governor-General of Australia, It was hoped soon to announce the date on which Lord Casey would be sworn-in.
- 3. MINISTRY.—Sir Robert Menzies (Prime Minister) informed the House that Mr. Barnes (Minister for Territories) had been appointed a member of the Cabinet.
- 4. Petitions.—Mr. Mortimer presented a petition from certain electors of the Division of Grey praying that the Commonwealth Government undertake to form and seal the Port Augusta-Woomera road between Wirrappa and Port Augusta to provide a reliable access road to Woomera and a better link for
 - Mr. Bryant presented a petition from certain citizens of the Commonwealth praying that the Government remove section 127, and the words discriminating against Aborigines in section 51, of the Commonwealth Constitution by the holding of a referendum at an early date.
