- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. MINISTERIAL ARRANGEMENTS.—Sir Robert Menzies (Prime Minister) informed the House that, during the absence abroad of Mr. Fairhall, Mr. Howson (Minister for Air) would act as Minister for Supply and Mr. Hasluck (Minister for External Affairs) would represent in this House the Minister for Defence.
- 3. QUESTIONS.—Questions without notice were asked.
- 4. Paper.—The following paper was presented, pursuant to statute—Wool Industry Act—Australian Wool Board—Report for year 1964-65.
- 5. Leave of Absence to Members.—Mr. Holt (Treasurer) moved, That leave of absence for two months be given to the honorable Members for Phillip (Mr. Aston) and Franklin (Mr. Falkinder) on the ground of Parliamentary business overseas.

 Question—put and passed.
- 6. Leave of Absence to Member.—Mr. McEwen (Minister for Trade and Industry) moved, That leave of absence for two months be given to the honorable Member for Gwydir (Mr. Allan) on the ground of Parliamentary business overseas.

- 7. Leave of Absence to Members.—Mr. Calwell (Leader of the Opposition) moved, That leave of absence for two months be given to the honorable Members for Adelaide (Mr. Sexton) and Reid (Mr. Uren) on the ground of Parliamentary business overseas.

 Ouestion—put and passed.
- 8. Special Adjournment.—Mr. Adermann (Minister for Primary Industry) moved, That the House, at its rising, adjourn until Tuesday, the 14th September, at half-past two o'clock p.m. Question—put and passed.
- 9. EXPORT PAYMENTS INSURANCE CORPORATION BILL 1965.—Mr. McEwen (Minister for Trade and Industry), pursuant to notice, presented a Bill for an Act to amend the Export Payments Insurance Corporation Act 1956–1964.

Bill read a first time.

Mr. McEwen moved, That the Bill be now read a second time.

Debate adjourned (Mr. Crean), and the resumption of the debate made an order of the day for the next sitting.

10. Melbourne (Tullamarine) Airport—Airport Works—Approval of work.—Mr. Freeth (Minister representing the Minister for Works) moved, pursuant to notice, That, in accordance with the provisions of the Public Works Committee Act 1913-1960, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the committee has duly reported to this House:—Provision of Additional Aprons, Vehicular Pavements, Electricity, Sewerage, Water Supply, Roads and Instrument Landing System for Melbourne (Tullamarine) Airport.

Debate ensued.

- 11. APPROPRIATION BILL (No. 1) 1965-66-BUDGET DEBATE.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time—And on the amendment moved thereto by Mr. Calwell (Leader of the Opposition), viz.:—That all words after "That" be omitted with a view to inserting the following words in place thereof:-" this House condemns the Budget because-
 - (1) such taxation increases as it contains add further burdens to wage and salary earners whose living standards have already been eroded by price rises and the Government's active intervention against wage increases;

(2) such meagre social service benefits as it proposes are inadequate, belated and partial in their application; and

(3) the Budget fails entirely to deal with such problems as increases in imports and Australia's dependence on foreign capital.

This House further declares that only by proper economic planning can Australia rapidly expand the resources required to meet its urgent needs in the fields of defence, development, education and social welfare "

Debate resumed.

Ouestion—That the words proposed to be omitted stand part of the question—put.
