- 1. The House met, at fifteen minutes to twelve o'clock noon, pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. Questions.—Questions without notice were asked.
- 3. PAPER.—The following paper was presented, pursuant to statute—

Australian Institute of Aboriginal Studies Act—Council of the Australian Institute of Aboriginal Studies—Report and financial statements, together with the Auditor-General's Report, for period 2nd June, 1964, to 30th June, 1965.

- 4. ALTERATION OF DAY OF NEXT MEETING.—Mr. Chaney (Minister for the Navy) moved, That the House, at its rising, adjourn until to-morrow at half-past nine o'clock a.m. Question—put and passed.

9. FOOT AND MOUTH DISEASE BILL 1965.—Mr. Swartz (Minister for Health), pursuant to notice, presented a Bill for an Act to amend the Foot and Mouth Disease Act 1961.

Bill read a first time.

Mr. Swartz moved, That the Bill be now read a second time.

Debate adjourned (Mr. Pollard), and the resumption of the debate made an order of the day for the next sitting.

15. Constitution Alteration (Repeal of Section 127) Bill 1965.—Sir Robert Menzies (Prime Minister), pursuant to notice, presented a Bill for an Act to alter the Constitution so that Aborigines are to be counted in reckoning the Population.

Bill read a first time.

Sir Robert Menzies moved, That the Bill be now read a second time.

Debate adjourned (Mr. Calwell—Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.

16. MEAT RESEARCH BILL 1965.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time—
