### WEDNESDAY, 24TH NOVEMBER, 1965.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.

- 3. INTERNATIONAL AID FOR EDUCATION IN PAPUA AND NEW GUINEA—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER.—Mr. Barnes (Minister for Territories), by leave, made a ministerial statement regarding two missions from the United Nations which would shortly visit Australia and Papua and New Guinea for the purpose of discussing four projects that might be undertaken as appropriate forms of assistance to education in the Territory. Mr. Barnes then, by command of His Excellency the Governor-General, presented the following paper:—
