- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. Petitions.—Mr. Cameron presented a petition from certain electors of the Commonwealth praying that the Australian Government withdraw our troops from, and call for an immediate cessation of hostilities in, Vietnam, and through world leaders seek a conference of conflicting parties aimed at permanent peace and self-determination of the Vietnamese people based on the principles of the 1954 Geneva Accords. Mr. Bryant presented a petition from certain citizens of the Commonwealth praying that the Commonwealth Government repeal the Wards' Employment Ordinance and legislate to provide at least the basic wage for all Aboriginal workers in the Northern Territory.

Petitions severally received and read.

"5A. Section 10 of the Principal Act is amended by omitting from sub-section (3.)
Accounts and the word 'Treasurer' and inserting in its stead the word 'Minister'."

Remainder of Bill, by leave, taken as a whole, and agreed to.

Bill to be reported with an amendment.

The House resumed; Mr. Failes reported accordingly.

On the motion of Mr. Howson, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

13. NAURU BILL 1965.—The order of the day having been read for the resumption of the debate on the question,
That the Bill be now read a second time—

Debate resumed by Mr. Beazley who moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof:—"this House, while not opposing the passage of the Bill, regrets that the Nauru Agreement between the three Governments set out in the second schedule contains no terms which provide for the political, economic, social and educational advancement of the indentured labourers in the phosphate industry".

Debate continued.

Question—That the words proposed to be omitted stand part of the question—put.
