On behalf of the House, Mr. Speaker extended to the visitors a warm welcome.
- 3. QUESTIONS .-- Questions without notice were asked.
- 4. PAPER.—The following paper was presented, by command of His Excellency the Governor-General— Norfolk Island—Report for year 1964–65.
- 5. BOEING 727 AIRCRAFT INCIDENT—MINISTERIAL STATEMENT.—Mr. Swartz (Minister for Civil Aviation), by leave, made a ministerial statement concerning an engine failure which occurred on a Boeing 727 aircraft at Sydney on the 16th March.
- 6. PUBLIC WORKS COMMITTEE—REPORT—STATEMENT BY MEMBER.—Mr. Brimblecombe (Chairman) brought up the following Report from the Parliamentary Standing Committee on Public Works:— Report relating to the proposed erection of a Migrant Hostel at Randwick, New South Wales and, by leave, made a statement in connexion with the report. - 7. - (2) its disapproval of and grave concern at the Government's failure-
 - (a) to maintain the purchasing power of the Australian community;
 - (b) to retain an adequate and proper Australian share in the ownership and development of our national resources, particularly in Northern Australia;
 - (c) to alleviate the effects of the drought and take steps to rehabilitate rural industries and conserve water resources;
 - (d) to make adequate provision for housing and associated community facilities, and

Point of order.—Mr. Daly raised a point of order that certain remarks of the honorable Member for Bennelong (Sir John Cramer) were offensive to Members of the Opposition and personally offensive to him.
