THURSDAY, 21st APRIL, 1966.

- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. QUESTIONS.—Questions without notice were asked.
- PAPER.—The following paper was presented, by command of His Excellency the Governor-General— New Guinea—Report to the General Assembly of the United Nations on Administration of New Guinea for year 1964-65.
- 4. QUEENSLAND SUGAR INDUSTRY—FINANCIAL RELIEF.—Mr. Patterson moved, pursuant to notice, That, in the opinion of this House, the Government should provide immediate financial relief to the Queensland sugar industry to overcome the serious economic situation existing in major sections of the industry, primarily as a result of the disastrously free market prices for sugar, the serious drought, and the fact that the economic health of the industry as a result of the recent expansion of the Queensland sugar industry is now greatly dependent on the export markets.
 - Debate ensued.
 - It being two hours after the time fixed for the meeting of the House, the debate was interrupted in accordance with standing order 109.
 - Ordered—That the time for the discussion of notices be extended until fifteen minutes to one o'clock p.m.

Debate continued.

- The time allotted for precedence to general business having expired, the debate was interrupted, Mr. Robinson was granted leave to continue his speech when the debate is resumed, and the resumption of the debate was made an order of the day for the next sitting.
- 5. WESTERN AUSTRALIA GRANT (BEEF CATTLE ROADS) BILL 1966.—Mr. Fairbairn (Minister for National Development), for Mr. Howson (Minister assisting the Treasurer), pursuant to notice, presented a Bill for an Act to amend the Western Australia Grant (Beef Cattle Roads) Act 1962. Bill read a first time.
 - Mr. Fairbairn moved, That the Bill be now read a second time.
 - Debate adjourned (Mr. Luchetti), and the resumption of the debate made an order of the day for the next sitting.
- 6. ASIAN DEVELOPMENT BANK BILL 1966.—Mr. Howson (Minister assisting the Treasurer), pursuant to notice, presented a Bill for an Act relating to the Asian Development Bank.
 - Bill read a first time. Mr. Howson moved, That the Bill be now read a second time.
 - Debate adjourned (Mr. Crean), and the resumption of the debate made an order of the day for the next sitting.
- 7. NATIONALITY AND CITIZENSHIP BILL 1966.—The House, according to order, resolved itself into a committee of the whole for the further consideration of the Bill.
