- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. QUESTIONS.—Questions without notice were asked.
- 3. Use OF CONFIDENTIAL REPORT IN DEBATE—STATEMENT BY SPEAKER.—Mr. Speaker stated in reply to a question asked yesterday by Mr. Calwell (Leader of the Opposition) that, subject to the rules applying to relevance and unparliamentary expressions, it was not within the province of the Chair to judge whether a document declared to be confidential should be restricted in its use in the House. The matter was not governed by standing orders and must be left to the good sense and discretion of a Member to determine whether or not he should use material in his possession.

TELEVISION STUDIOS, GORE HILL, NEW SOUTH WALES—BUILDING EXTENSIONS—APPROVAL OF WORK.—Mr. Freeth (Minister representing the Minister for Works) moved, pursuant to notice, That, in accordance with the provisions of the *Public Works Committee Act* 1913–1965, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the committee has duly reported to this House:—Provision of building extensions and central air-conditioning plant at the A.B.C. Television Studios, Gore Hill, New South Wales.

- 9. C.S.I.R.O. LABORATORIES, INDOOROOPILLY, QUEENSLAND—APPROVAL OF WORK.—Mr. Freeth (Minister representing the Minister for Works) moved, pursuant to notice, That, in accordance with the provisions of the *Public Works Committee Act* 1913–1965, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the committee has duly reported to this House:—Provision of laboratories for the Commonwealth Scientific and Industrial Research Organization at Indooroopilly, Queensland.  LOAN (DEFENCE) BILL 1966.—Mr. McMahon (Treasurer), pursuant to notice, presented a Bill for an Act to Authorize the Raising and Expending of a certain sum of money for Defence Purposes. Bill read a first time.

Mr. McMahon moved, That the Bill be now read a second time.

Debate adjourned (Mr. Crean), and the resumption of the debate made an order of the day for the next sitting.

- 16. BANKRUPTCY BILL 1966.—SENATE'S AMENDMENTS.—The House, according to order, resolved itself into a committee of the whole to consider the amendments made by the Senate.

SCHEDULE OF THE AMENDMENTS MADE BY THE SENATE.

No. 1—Page 11, clause 23, paragraph (b), line 31, after "State" insert " or of a Territory ".

No. 2-Page 18, clause 39, lines 41 to 44, leave out sub-clause (2.), insert the following sub-clause:-

"(2.) An appeal lies to the High Court from an order of the Court, being-

(a) a sequestration order;

- (b) an order convicting a person of an offence against this Act-
 - (i) on a question of fact—involving a fine exceeding Two hundred dollars or imprisonment for six months;

(ii) on a question of law; or

(c) an order involving a civil right or property amounting to, or of the value of, Three thousand dollars.".

No. 3—Page 52, clause 109, sub-clause (1.), paragraph (g), line 2, leave out "by accident".

No. 4-Page 75, clause 139, after sub-clause (3.), add the following sub-clause:-

"(4.) This section does not affect any liability of the trustee of the estate of a bankrupt other than personal liability.".

No. 5—Page 77, clause 149, sub-clause (2.), lines 19 and 20, leave out "five years from the commencement of this Act ", insert " three years from the commencement of this Act or five years from the date on which the sequestration order was made against his estate or he otherwise became a bankrupt, whichever is the later ".

No. 6-Page 109, clause 216, lines 26 to 28, leave out sub-clause (3.).

Amendment No. 1-

On the motion of Mr. Snedden (Attorney-General), the amendment was agreed to.

Amendment No. 2-

Mr. Snedden moved, That Senate Amendment No. 2 be disagreed to, but that, in place thereof, clause 39 be amended as follows:—

Page 18, lines 41 to 44, omit sub-clause (2.), insert the following sub-clause:---

"(2.) An appeal lies to the High Court-

- (a) from a sequestration order made by the Court;
- (b) from a judgment or order of the Court involving directly or indirectly a claim, demand or question to or respecting any property or any civil right amounting to or of the value of Three thousand dollars;
- (c) from an order of the Court convicting a person of an offence against this Act, being an order that imposes a sentence of imprisonment for a period exceeding six months; or
- (d) on a question of law, from any order of the Court convicting a person of an offence against this Act.".

Debate ensued.

Question-put and passed.

Amendments Nos. 3 to 6-

On the motion of Mr. Snedden, the amendments were together agreed to. Resolutions to be reported.

The House resumed; Mr. Lucock reported accordingly. On the motion of Mr. Snedden, the House adopted the report.
