- 2. ABSENCE OF MR. Speaker.—The Acting Clerk having informed the House that Mr. Speaker (the Honorable Sir John McLeay) was unavoidably absent on Parliamentary business overseas, the Chairman of Committees (Mr. Lucock) took the Chair as Acting Speaker, and read Prayers.
- 3. Petition.—Mr. Luchetti presented a petition from certain citizens of the Commonwealth praying that action be taken, through Constitution alteration referendum proposals, to give the Commonwealth power to make laws for the advancement of the Aboriginal people and prevent the making of laws which would discriminate against any person born or naturalized in Australia. Petition received and read.
- 4. MINISTERIAL ARRANGEMENTS.—Mr. Holt (Prime Minister) informed the House that, during the absence abroad of Mr. McMahon, he would act as Treasurer.
