4. AIRCEAFT ACCIDENTS NEAR WINTON, QUEENSLAND AND TENNANT CREEK, NORTHERN TERRITORY—
MINISTERIAL STATEMENT.—Mr. Swartz (Minister for Civil Aviation), by leave, made a ministerial
statement informing the House of further developments in the investigation of the crash, on Thursday,
22nd September, of the Viscount airliner near Winton, Queensland and of his intention to appoint a
Board of Accident Inquiry. Mr. Swartz also referred to the crash of an aircraft owned by an aerial
survey company which occurred near Tennant Creek airport at the week-end in which six people lost
their lives and to the technical investigation which had begun into the circumstances of this crash.

Mr. Heaton and Mr. J. F. Cairns, by leave, also made statements with reference to the matter.

Mr. Swartz, by leave, made a further statement on the subject.

6. Message from the Senate-Repatriation Bill 1966.-Mr. Acting Speaker reported message No. 316, dated 22nd September, 1966, from the Senate transmitting for the concurrence of the House a Bill for "An Act to amend the 'Repatriation Act 1920–1965'."

Bill read a first time.

Mr. Swartz (Minister representing the Minister for Repatriation) moved, That the Bill be now read a second time.

Debate adjourned (Mr. Pollard), and, by leave, the resumption of the debate made an order of the day for a later hour this day.

7. Social Services Bill 1966.—The House, according to order, resolved itself into a committee of the whole for the further consideration of the Bill.

Remainder of Bill, by leave, taken as a whole, and agreed to, after debate.

Bill to be reported without amendment.

8. SEAMEN'S WAR PENSIONS AND ALLOWANCES BILL 1966.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time-

On the motion of Mr. Freeth (Minister for Shipping and Transport), the Bill was read a third time.
