Page 3, line 39, omit "five years", insert "four years".

Page 3, proposed section 54c, sub-section (1.), omit paragraph (b). Page 4, line 1, omit "on and from", insert "on or after".

Page 4, proposed section 54c, sub-section (1.), omit paragraphs (e), (f) and (g), insert the following paragraphs:

"(e) where the period of her service is not less than four years but is less than eight years—an amount equal to her salary for two months;

- (f) where the period of her service is not less than eight years but is less than ten years—an amount equal to her salary for three months; or
- (g) where the period of her service is not less than ten years—an amount equal to her salary for three-tenths of one month in respect of each year of the period of her service.".
