THURSDAY, 9 MARCH 1967

- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 Petition: Mr Arthur presented a petition from certain citizens of New South Wales praying that the Australian Government increase by an immense amount its contributions to non-military overseas aid, such aid to be financed, if necessary, by increases in taxation, administered by some international organisation such as the United Nations and offered to countries without reference to political advantage or purposes, but solely on the basis of need.

Petition received.

- 3 QUESTIONS: Questions without notice were asked.
- 4 Messages from the Senate: Messages from the Senate were reported returning the following Bills without amendment:
 - 8 March 1967-Message-
 - No. 7—Constitution Alteration (Parliament) 1967.
 - No. 8—Constitution Alteration (Aboriginals) 1967.
- 5 House Committee: Mr Hasluck (Minister for External Affairs) moved, by leave—That Mr C. K. Jones be discharged from attendance on the House Committee, and that, in his place, Mr McIvor be appointed a member of the committee.

 Ouestion—put and passed.
- 6 Suspension of standing orders—Diplomatic Privileges and Immunities Bill and Associated Bills: Mr Hasluck (Minister for External Affairs) moved, pursuant to notice—That so much of the standing orders be suspended as would prevent a Diplomatic Privileges and Immunities Bill and five associated Bills—
 - (a) being presented and read a first time together and one motion being moved without delay and one question being put in regard to, respectively, the second readings, the committee's report stage, and the third readings, of all the Bills together, and
 - (b) the consideration of the Bills in one committee of the whole.

Question-put and passed.

- 7 DIPLOMATIC PRIVILEGES AND IMMUNITIES, CUSTOMS TARIFF (No. 2), EXCISE TARIFF, INCOME TAX ASSESSMENT, PAY-ROLL TAX ASSESSMENT AND SALES TAX (EXEMPTIONS AND CLASSIFICATIONS) BILLS 1967: Mr Hasluck (Minister for External Affairs) presented the following Bills:
 - A Bill for an Act relating to Diplomatic Privileges and Immunities, and for other purposes;
 - A Bill for an Act relating to the Exemption from Duties of Customs of Goods for the use of certain Representatives of Governments of Countries other than Australia and their Staffs and Families;

- A Bill for an Act relating to the Exemption from Duties of Excise of Goods for the use of certain Representatives of Governments of Countries other than Australia and their Families;
- A Bill for an Act relating to the Exemption from Income Tax of Income of certain Representatives of Governments of Countries other than Australia and their Staffs and Families;
- A Bill for an Act relating to the Exemption from Pay-roll Tax of Wages paid by certain Representatives of Governments of Countries other than Australia; and
- A Bill for an Act relating to the Exemption from Sales Tax of Goods for the use of Governments of Countries other than Australia and for the use of certain Representatives of those Governments and their Staffs and Families.

Bills together read a first time.

Mr Hasluck moved—That the Bills be now read a second time.

Debate adjourned (Mr Whitlam—Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.

Mr Snedden expressed appreciation of the services which had been rendered by Mr Drury.

- 13 Manning of M. V. Jeparit—Ministerial statement: Mr Chipp (Minister for the Navy), by leave, made a ministerial statement informing the House of the arrangements made for naval sailors to replace members of the Seamen's Union in the manning of the M. V. Jeparit on a voyage to South Viet Nam.
