# TUESDAY, 4 APRIL 1967

- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 MINISTERIAL ARRANGEMENTS: Mr McEwen (Minister for Trade and Industry) informed the House that, during the absence abroad of Mr Holt (Prime Minister), he would act as Prime Minister.
  - Mr McEwen also informed the House that, during the absence abroad of Mr Hasluck (Minister for External Affairs), Senator Gorton would act as Minister for External Affairs. Mr McEwen stated that he would deal with External Affairs matters in this House.
- 3 QUESTIONS: Questions without notice were asked.
- 4 PAPER: The following paper was presented, pursuant to statute:
  - Honey Industry Act—Australian Honey Board—Third Annual Report and financial statements, together with the Auditor-General's Report, for year 1965-66.
- 5 Message from the Governor-General—Assent to Bill: A message from His Excellency the Governor-General was announced informing the House that His Excellency, in the name of Her Majesty, had assented to the following Bill: 20 March 1967—Message No. 5—Public Service 1967.
- 6 NATIONALITY AND CITIZENSHIP BILL 1967: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
  - Debate resumed by Mr Barnard who moved, as an amendment—That all words after "That" be omitted with a view to inserting the following words in place thereof: "the Bill be withdrawn and redrafted to provide that a person who becomes a member of the permanent forces of the Commonwealth shall be immediately eligible for Australian citizenship".

Debate continued.

- Debate adjourned (Mr Cleaver), and the resumption of the debate made an order of the day for a later hour this day.

10 MEDICAL EVACUATION FROM VIET NAM—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER: Mr Fairhall (Minister for Defence), by leave, made a ministerial statement with reference to the aero-medical evacuation of wounded servicemen from Viet Nam, and, by command of His Excellency the Governor-General, presented the following paper:

Medical Evacuation from Viet Nam—Ministerial statement—and moved—That the House take note of the paper.

Debate adjourned (Mr Barnard—Deputy Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.

11 SOCIAL SERVICES BILL 1967: Mr Sinclair (Minister for Social Services), by leave, presented a Bill for an Act to amend the *Social Services Act* 1947–1966.

Bill read a first time.

Mr Sinclair moved—That the Bill be now read a second time.

Debate adjourned (Mr Daly), and the resumption of the debate made an order of the day for the next sitting.
