15 PETROLEUM (SUBMERGED LANDS) LEGISLATION—EXPLORATION AND PRODUCTION TITLES—
MINISTERIAL STATEMENT—PAPERS: Mr Fairbairn (Minister for National Development), by leave, made a ministerial statement with reference to the tabling of certain Off-shore Exploration and Production Titles for oil and gas proposed to be recognised under the Petroleum (Submerged Lands) legislation before the House, and, by command of His Excellency the Governor-General, presented the following papers:

Petroleum (Submerged Lands) Legislation—

Production titles—Victoria—Barracouta and Marlin fields—Map of areas covered

Exploration titles—

Map and explanatory key showing the exploration titles issued up to December 1966, and the persons to whom they were issued.

Summary of off-shore petroleum titles as at 30 June 1967 showing the State or Territory, title number, holder of the title, area, date of expiry and whether or not the title is wholly off-shore.

New South Wales—Copy of Exploration Licence 112 issued to Shell Development (Australia) Pty Ltd, typical of other licences issued in New South Wales.

Victoria—Copy of Permit Number 57 issued to Shell Development (Australia) Pty Ltd, typical of all permits issued in Victoria, together with a copy of the relevant regulations under which the Permit was issued.

Queensland—Copy of Authority to Prospect 127P issued to Corbett Reef Limited, generally following that of all previous off-shore Authorities to Prospect issued in Queensland.

South Australia—Copy of the prescribed general form which licences issued in that State must follow.

Western Australia—Copy of Permit to Explore 27H issued to West Australian Petroleum Pty Ltd, typical of other exploration permits issued in Western Australia.

Tasmania—Copy of Exploration Permit Number 5/67 issued to Magellan Petroleum Southern Pty Ltd, generally in line with other exploration permits issued in Tasmania.

Northern Territory and the Territory of Ashmore and Cartier Islands—Copy of typical off-shore exploration permit.

Territory of Papua and New Guinea—Copy of typical off-shore exploration permit.
