TUESDAY, 30 APRIL 1968

- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 COMMONWEALTH PARLIAMENTARY ASSOCIATION DELEGATION FROM SABAH: Mr Speaker informed the House that a delegation of six members of the Sabah Branch of the Commonwealth Parliamentary Association, led by Dato Haji Mohd. Kassim bin Haji Hashim, P.D.K., Speaker of the Legislative Assembly, and including Mr Wong Lok Khiam, A.D.K., Minister of Health, was present in the gallery of the House. On behalf of the House and the Commonwealth of Australia Branch of the Association, Mr Speaker extended to the delegation a cordial welcome.
- 3 HER MAJESTY QUEEN ELIZABETH THE SECOND—ADDRESS IN REPLY: Mr Speaker informed the House that he had received from His Excellency the Governor-General the following communication in connection with the Address in Reply:

MR SPEAKER,

I desire to acquaint you that the substance of the Address-in-Reply which you presented to me on the 4th April, 1968, has been communicated to Her Majesty The Oueen.

It is The Queen's wish that I convey to you and Honourable Members of the House of Representatives Her Majesty's sincere thanks for the loyal message to which your Address gives expression.

4 Petition: Mr Scholes presented a petition from certain telephone subscribers of the district of Shelford in the Division of Corio praying that this House take immediate action to make it possible for all persons in rural areas to share the benefits of advanced means of communication without financial disability.

Petition received and read.

- 5 MINISTERIAL ARRANGEMENTS: Mr Gorton (Prime Minister) informed the House that during the respective absences abroad of Mr McEwen (Minister for Trade and Industry) and Mr Bowen (Attorney-General), Mr Sinclair (Minister for Shipping and Transport) was acting as Minister for Trade and Industry and Mr Snedden (Minister for Immigration) was acting as Attorney-General.
- 6 QUESTIONS: Questions without notice being asked—
 - Tribute to Dr Martin Luther King: At the request of Mr Calwell and with the agreement of Mr Gorton (Prime Minister) and Mr Speaker, but on the understanding that this departure from practice would not create a precedent, honourable Members stood in silence as a mark of respect to Dr Martin Luther King, a world figure who was recently assassinated in the United States of America.

Questions without notice continued.

7 PAPER: The following paper was presented, pursuant to statute:

- 8 Australian Capital Territory—Joint Committee: Mr Nixon (Minister for the Interior) moved, by leave—
 - (1) That the Joint Committee on the Australian Capital Territory or any sub-committee thereof, when considering certain matters relating to the desirability of establishing a fruit and vegetable market in the Australian Capital Territory which were referred to the Committee on 13 March 1968, have power to move from place to place.
 - (2) That a message be sent to the Senate requesting its concurrence. Question—put and passed.
- 9 Public Works Committee—Report: Mr Chaney (Chairman) brought up the following report from the Parliamentary Standing Committee on Public Works:

Report relating to the proposal for extensions to Commonwealth Offices, Brisbane. Ordered to be printed.

10 Message from the Governor-General—Assent to Bill: A message from His Excellency the Governor-General was announced informing the House that His Excellency, in the name of Her Majesty, had assented to the following Bill:

16 April 1968—Message No. 3—New South Wales Grant (Flood Mitigation) 1968.

11 NAVAL DEFENCE BILL 1968: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time— Debate resumed.

Question—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

In the committee

Clauses 1 to 6, by leave, taken together, and agreed to.

Clause 7 omitted, after debate.

Title agreed to.

Bill to be reported with an amendment.

The House resumed; Mr Fox reported accordingly.

On the motion of Mr Kelly (Minister for the Navy), by leave, the House adopted the report, and, by leave, the Bill was read a third time.

12 INCOME TAX (INTERNATIONAL AGREEMENTS) BILL 1968: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Message from the Governor-General: Mr Speaker announced the receipt of message No. 4, dated 28 March 1968, from His Excellency the Governor-General recommending an appropriation of revenue for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Freeth (Minister assisting the Treasurer), the Bill was read a third time.

13 INCOME TAX ASSESSMENT BILL 1968: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Freeth (Minister assisting the Treasurer), the Bill was read a third time.

14 Science and Industry Research Bill 1968: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Snedden (Minister for Immigration), the Bill was read a third time.

15 NATIVE MEMBERS OF THE FORCES BENEFITS BILL 1968: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question-put and passed-Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Snedden (Minister for Immigration), the Bill was read a third time.

16 Removal of Prisoners (Territories) Bill 1968: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time.—

Debate resumed.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Snedden (Minister for Immigration), the Bill was read a third time.

17 NORTHERN TERRITORY (ADMINISTRATION) BILL 1968: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Nixon (Minister for the Interior), the Bill was read a third time.

18 OFFICERS' RIGHTS DECLARATION BILL 1968: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Nixon (Minister for the Interior), the Bill was read a third time.

19 NORTHERN TERRITORY REPRESENTATION BILL 1968: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Ouestion—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

In the committee

Bill, by leave, taken as a whole.

On the motion of Mr Nixon (Minister for the Interior), clause 2 was omitted, and the following clause inserted in place thereof, after debate:

"2. This Act shall come into operation on the day on which it Commencement. receives the Royal Assent.".

Bill, as amended, agreed to.

Bill to be reported with an amendment.

The House resumed; Mr Lucock reported accordingly.

On the motion of Mr Nixon, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

20 ADJOURNMENT: Mr Snedden (Leader of the House) moved—That the House do now adjourn.

Debate ensued.

Question-put and passed.

And then the House, at nine minutes past eleven o'clock p.m., adjourned until tomorrow at half-past two o'clock p.m.
