THURSDAY, 16 MAY 1968

- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr Benson presented a petition from certain citizens of the Commonwealth praying that this House will make a survey of the full requirements of pensioners of all types and adopt a policy for the progressive liberalisation of the means test resulting in its removal within three years.

Petition received and read.

Similar petitions were presented by Mr Fox and Mr Bryant, and were severally received. Mr C. K. Jones presented a petition from certain electors of the Commonwealth praying that the Government implement Article 25 of the Universal Declaration of

Human Rights by providing increased social service and housing benefits for the aged, the invalid, the widowed and their dependants.

Mr J. F. Cairns presented a petition from certain citizens of Australia praying that the amending National Service Bill be defeated so that it may have no effect. Petitions severally received and read.

- 3 QUESTIONS: Questions without notice were asked.
- 4 NATIONAL WATER RESOURCES DEVELOPMENT PROGRAMME—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER: Mr Fairbairn (Minister for National Development), by leave, made a ministerial statement informing the House of six projects which, under the National Water Resources Development Programme, had been selected for closer study, and, by command of His Excellency the Governor-General, presented the following paper:

Mr Snedden (Leader of the House) moved—That the House take note of the paper. Mr Patterson, by leave, also made a statement with reference to the matter.

5 NORTHERN TERRITORY LEGISLATIVE COUNCIL—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER: Mr Nixon (Minister for the Interior), by leave, made a ministerial statement informing the House that the Government had decided that the three nominated non-official Members of the Legislative Council for the Northern Territory be replaced by three elected Members and that the necessary legislation would be introduced at an early date. Mr Nixon then, by command of His Excellency the Governor-General, presented the following paper:

7 COPYRIGHT BILL 1968: Mr Bowen (Attorney-General), pursuant to notice, presented a Bill for an Act relating to Copyright, and for other purposes.

Bill read a first time.

Mr Bowen moved—That the Bill be now read a second time.

Debate adjourned (Mr Connor), and the resumption of the debate made an order of the day for the next sitting.

8 DESIGNS BILL 1968: Mr Bowen (Attorney-General), pursuant to notice, presented a Bill for an Act to amend the Designs Act 1906-1967.

Bill read a first time.

Mr Bowen moved-That the Bill be now read a second time.

Debate adjourned (Mr Connor), and the resumption of the debate made an order of the day for the next sitting,

9 JUDGES' PENSIONS BILL 1968: Mr Bowen (Attorney-General), pursuant to notice, presented a Bill for an Act to make provision for Pensions for Judges and their Families. Bill read a first time.

Mr Bowen moved—That the Bill be now read a second time.

Debate adjourned (Mr Connor), and the resumption of the debate made an order of the day for the next sitting.

(b) by omitting sub-sections (3.) and (4.).".
