- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 QUESTIONS: Questions without notice were asked.
- 3 HELICOPTER ACCIDENT AT BARRACOUTA PLATFORM, BASS STRAIT—PAPER AND MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPERS: Mr Swartz (Minister for Civil Aviation), by command of His Excellency the Governor-General, presented the following paper:

- 4 CZECHOSLOVAKIA—MINISTERIAL STATEMENT AND MOTION: Mr Hasluck (Minister for External Affairs), by leave, made a ministerial statement with reference to the armed intervention in Czechoslovakia by Russia, East Germany, Poland, Hungary and Bulgaria.
 - Mr Hasluck moved, by leave—That the House expresses its distress at and its abhorrence of the armed intervention in Czechoslovakia by the Union of Soviet Socialist Republics, the East German regime, Poland, Hungary, and Bulgaria; condemns this action as a breach of the United Nations Charter and of accepted international conduct; calls for the immediate withdrawal of the forces unlawfully on Czechoslovakian territory and expresses the sympathy of the House for the people of Czechoslovakia in their ordeal.

Debate ensued.

- 5 ABORIGINAL POLICY—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER: Mr Wentworth (Minister in charge of Aboriginal Affairs), by leave, made a ministerial statement with reference to discussions which he had had recently with various State Ministers in charge of Aboriginal Affairs concerning proposals for Aboriginal advancement, and, by command of His Excellency the Governor-General, presented the following paper:

6 PROCESSED MILK PRODUCTS BOUNTY BILL 1968: Mr Anthony (Minister for Primary Industry), pursuant to notice, presented a Bill for an Act to amend section 4 of the *Processed Milk Products Bounty Act* 1962–1967.

Bill read a first time.

Mr Anthony moved—That the Bill be now read a second time.

Debate adjourned (Mr Beaton), and the resumption of the debate made an order of the day for the next sitting.

7 PHOSPHATE FERTILIZERS BOUNTY BILL 1968: Mr Anthony (Minister for Primary Industry), pursuant to notice, presented a Bill for an Act to amend the *Phosphate Fertilizers Bounty Act* 1963-1966.

Bill read a first time.

Mr Anthony moved-That the Bill be now read a second time.

Debate adjourned (Mr Beaton), and the resumption of the debate made an order of the day for the next sitting.

8 Post and Telegraph Rates Bill 1968: Mr Hulme (Postmaster-General), pursuant to notice, presented a Bill for an Act relating to Postal Charges.

Bill read a first time.

Mr Hulme moved—That the Bill be now read a second time.

Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.

- 9 APPROPRIATION BILL (No. 1) 1968-69—BUDGET DEBATE: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr Whitlam (Leader of the Opposition), viz.—That all words after "That" be omitted with a view to inserting the following words in place thereof: "this House is of opinion that the Budget is inadequate in that it does not make provision—
 - (a) to lighten taxes and health costs for families and to increase benefits for them,

(b) to plan defence procurement and expenditure,

- (c) to meet the problems of Australia's capital and provincial cities, and
- (d) to retain control and promote development of Australia's mineral, fuel, land and marine resources"—

Debate resumed.

Debate adjourned (Mr O'Connor), and the resumption of the debate made an order of the day for a later hour this day.

10 PAPER: Mr Speaker presented, pursuant to statute:

Reserve Bank Act—Reserve Bank of Australia—Report and financial statements, together with Auditor-General's Reports thereon, for year 1967-68.

11 CZECHOSLOVAKIA: The order of the day having been read for the resumption of the debate on the following motion of Mr Hasluck (Minister for External Affairs): That the House expresses its distress at and its abhorrence of the armed intervention in Czechoslovakia by the Union of Soviet Socialist Republics, the East German regime, Poland, Hungary, and Bulgaria; condemns this action as a breach of the United Nations Charter and of accepted international conduct; calls for the immediate withdrawal of the forces unlawfully on Czechoslovakian territory and expresses the sympathy of the House for the people of Czechoslovakia in their ordeal.

Debate resumed.

Ordered—That Mr Gorton (Prime Minister) be granted an extension of time. Debate continued.

Suspension of standing orders—Record of names of Members in favour of the motion:

Mr Gorton moved—That the standing orders be suspended to enable the names of those in favour of the motion to be taken down by tellers and recorded in the Votes and Proceedings so that the opinion of this House can be made known to the world.

Question—put and passed, with the concurrence of an absolute majority.

- Question—That the House expresses its distress at and its abhorrence of the armed intervention in Czechoslovakia by the Union of Soviet Socialist Republics, the East German regime, Poland, Hungary, and Bulgaria; condemns this action as a breach of the United Nations Charter and of accepted international conduct; calls for the immediate withdrawal of the forces unlawfully on Czechoslovakian territory and expresses the sympathy of the House for the people of Czechoslovakia in their ordeal—put.
- Mr Speaker directed that the bells be rung. The bells having ceased ringing, Mr Speaker again put the question, and there being no dissentient voice, directed that the names of those Members agreeing to the question be recorded, and appointed tellers.
