- 2 PETITION: Mr Daly presented a petition from certain residents of Australia praying that the Government use its influence to achieve the release of all political prisoners, the holding of free elections and the restoration of all other constitutional and democratic rights in Greece and that the Government take steps to prevent further intimidation of Greek migrants in Australia by representatives of the Greek military dictatorship. Petition received and read.

Question-put and passed.

- 8 ELECTORAL DIVISIONS OF NEW SOUTH WALES—PROPOSED REDISTRIBUTION: The order of the day having been read for the resumption of the debate on the motion of Mr Nixon (Minister for the Interior): That the House of Representatives approves of the redistribution of the State of New South Wales into Electoral Divisions as proposed by Messrs F. L. Ley, C. W. Prince and R. F. Mallon, the Commissioners appointed for the purpose of redistributing the said State into Divisions, in their Report laid before the House of Representatives on the 18th day of September, 1968, and that the names of the Divisions suggested in the Report, and indicated in the map referred to therein, be adopted, except that the name "Ku-ring-gai" be substituted for "Hornsby" and the name "Grose" be substituted for "Blacktown" and the name "Cook" be substituted for "Kurnell"—
 - Motion amended by Mr Nixon, by leave, by omitting the name "Ku-ring-gai" and inserting the name "Berowra" in place thereof.
 - Debate resumed by Mr Whitlam (Leader of the Opposition) who moved, as an amendment—That the words "the House of Representatives approves of the redistribution of the State of New South Wales into Electoral Divisions as proposed by Messrs F. L. Ley, C. W. Prince and R. F. Mallon, the Commissioners appointed for the purpose of redistributing the said State into Divisions, in their Report laid before the House of Representatives on the 18th day of September, 1968, and" be omitted with a view to inserting the following words in place thereof: ", since the distribution provides for a greater equality of population in the proposed Divisions than has been allowed to develop in the existing Divisions, the House of Representatives accepts the redistribution of the State of New South Wales into Electoral Divisions as proposed by Messrs F. L. Ley, C. W. Prince and R. F. Mallon, the Commissioners appointed for the purpose of redistributing the said State into Divisions, in their Report laid before the House of Representatives on the 18th day of September, 1968, but does so with reluctance since the distribution:
 - (1) permits a greater inequality of population in the proposed Divisions than has occurred in any previous distribution;
 - (2) fails to provide that as nearly as is practicable one man's vote is to be worth as much as another's; and
 - (3) ignores the Constitution's plain objective of making equal representation for equal numbers of people the fundamental goal for the House of Representatives,

and agrees".

- *Point of order:* Mr Snedden (Leader of the House) raised a point of order that the amendment was out of order as it would have no different effect than the motion before the House.
- Speaker's ruling: Mr Speaker ruled that the amendment was relevant to the motion and was, therefore, in order.

- Debate adjourned (Mr K. M. K. Cairns), and the resumption of the debate made an order of the day for a later hour this day.
- 9 STATES GRANTS (PRE-SCHOOL TEACHERS COLLEGES) BILL 1968: Mr J. M. Fraser (Minister for Education and Science), by leave, presented a Bill for an Act to grant Financial Assistance to the States for the purposes of Building Projects in connexion with Pre-School Teachers Colleges.

Bill read a first time.

Mr Fraser moved—That the Bill be now read a second time.

- Debate adjourned (Mr Barnard—Deputy Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.
- 10 STATES GRANTS (SECONDARY SCHOOLS LIBRARIES) BILL 1968: Mr J. M. Fraser (Minister for Education and Science), by leave, presented a Bill for an Act to grant Financial Assistance to the States for Libraries at Secondary Schools and for the acquisition of Library Material and Equipment for use in such Libraries.

Bill read a first time.

Mr Fraser moved-That the Bill be now read a second time.

Debate adjourned (Mr Barnard—Deputy Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.

- 11 JUDICIARY ACT—CONSIDERATION BY COMMITTEE—MINISTERIAL STATEMENT: Mr Bowen (Attorney-General), by leave, made a ministerial statement informing the House that a committee had been appointed to consider the Judiciary Act and to report to the Government whether any alterations should be made to the Act.
