- 1 The House met, at five minutes to three o'clock p.m. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 DEATH OF FORMER MEMBER (THE HONOURABLE J. A. J. HUNTER): Mr Speaker referred to the death, on 26 October, of the Honourable James Aitchison Johnston Hunter, a Member of this House for the Division of Maranoa from 1921 to 1940 and from 1934 to 1937 a Minister without portfolio.
 - As a mark of respect to the memory of the late honourable gentleman all Members present rose, in silence.
- 3 MINISTERIAL ARRANGEMENTS: Mr Gorton (Prime Minister) informed the House that, during the absence through indisposition of Mr J. M. Fraser (Minister for Education and Science), Senator Wright (Minister for Works) would act as Minister for Education and Science and Mr Forbes (Minister for Health) would handle matters relating to education and science in this House.

9 VIETNAM BOMBING HALT—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER: Mr Gorton (Prime Minister), by leave, made a ministerial statement regarding recent developments concerning Vietnam and the announcement of the President of the United States to cease the bombing of North Vietnam, and, by command of His Excellency the Governor-General, presented the following paper:

Vietnam bombing halt-Ministerial statement, 5 November 1968.

Mr Snedden (Leader of the House) moved—That the House take note of the paper. Suspension of standing orders—Extended time for speech: Mr Snedden moved, by leave—

That so much of the standing orders be suspended as would prevent Mr Whitlam (Leader of the Opposition) speaking without limitation of time.
