- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 PETITION: Mr Benson presented a petition from certain residents of Victoria praying that the Commonwealth Government place an immediate and total ban on the export of all kangaroo meat and fur products and set up a body to administer conservation of kangaroos in all States of Australia.
 Petition received.
- 3 QUESTIONS: Questions without notice were asked.
- 4 PRIME MINISTER—MINISTERIAL STATEMENT: Mr Gorton (Prime Minister), by leave, made a ministerial statement regarding certain statements with respect to him which had been made in the House on Thursday night last.
- 5 Paper: The following paper was presented, pursuant to statute:

- 6 HEALTH INSURANCE—REPORT AND MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPERS: Mr Forbes (Minister for Health), by command of His Excellency the Governor-General, presented the following paper:

Mr Forbes, by leave, made a ministerial statement in connection with the report, and, by command of His Excellency the Governor-General, presented the following paper: Health Insurance—Report of Commonwealth Committee of Enquiry—Ministerial statement, 25 March 1969.

8 SOUND BROADCASTING STUDIOS FOR AUSTRALIAN BROADCASTING COMMISSION, COLLINSWOOD, S.A.—APPROVAL OF WORK: Mr Kelly (Minister representing the Minister for Works) moved, pursuant to notice—That, in accordance with the provisions of the *Public Works Committee Act* 1913–1966, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the committee has duly reported to this House: Construction of sound broadcasting studios at Collinswood, S.A., for the Australian Broadcasting Commission.
